1. <u>Call to Order</u>.

Board President Baldemar Garcia called the Regular Meeting of the Ricardo Water Supply Corporation Board of Directors to order at 5:30 p.m. A quorum was present.

2. <u>Citizen comments</u>.

Mr. Garcia opened the floor to citizen comments. No comments were made.

3. <u>Approval of Minutes</u>.

Mr. Escobedo made a motion to approve the minutes of the October 5, 2021 Regular Meeting as presented. Mr. Robertson seconded. All voted in favor of approving the minutes as presented.

4. Treasurer's Report/Payment of Bills.

The following financial reports were presented for Board review and approval:

A motion was made by Mr. Robertson and seconded by Mr. Hinojosa to approve the Treasurer's Report and payment of the bills. The motion carried.

5. Fiscal Year 2021 Budget Amendments.

Mr. Marez reviewed the proposed Fiscal Year 2021 Amended Budget which reflected a Revenue increase of \$132,082 of which \$53,415 is related to the TxDOT reimbursement. Total Operating Expenses increased by \$48,827.50 and overall Net operating income increased by \$83,254 from the original adopted budget.

Mr. Fischer made a motion to approve the Fiscal Year 2021 Budget Amendments. Mr. Garza seconded. All voted in favor.

6. <u>Proposed Fiscal Year 2022 Budget and retail water rates.</u>

The Board reviewed a proposed Fiscal Year 2022 Budget based on the current rates along with three additional scenarios with various monthly minimum and thousand-gallon rate increases. Mr. Garcia stated that he preferred to maintain the current rates. Ms. Wagner also recommended keeping the current rates.

7. **Resolution 21-04**. Resolution adopting the recommended Fiscal Year 2022 Budget.

Mr. Robertson made a motion to adopt the Fiscal Year 2022 Budget based on the current monthly minimum of \$41.00 on a 5/8" meter and water rates of \$4.25/1000g up to 20,000 gallons and \$4.45/1000g over 20,000 gallons. Mr. Escobedo seconded and all voted in favor.

8. John Womack & Co., P.C. Letter of Engagement for auditor services.

The Board reviewed the John Womack & Co., P.C. Letter of Engagement in the amount of \$5,575 for auditor services for a basic audit of RWSC's financial statements for the year ended December 31, 2021. After reviewing the letter, Mr. Escobedo made a motion to accept the engagement letter for FY 2021 audit services with John Womack & Co., P.C. in the amount of \$5,575. Mr. Garza seconded the motion. All voted in favor.

9. <u>Correction of Title/Job Function for John Marez</u>.

Mr. Marez stated that at the July meeting, the RWSC Board approved him as General Manager of RWSC. At the October 5, 2021 RWSC meeting, Mr. Zavala pointed out that Mr. Marez was appointed General Manager contingent on STWA hiring Mr. Marez as Executive Director and questioned the validity of the previous Board action since Mr. Marez is serving as Administrator for STWA. Mr. Marez added that at their most recent meeting, the NWSC Board voted not to confer the title of General Manager to Mr. Marez. He asked that the Board determine whether to remove the job title to match the concern of having the Water Supply Corporations' title of General Manager be in sync with STWA's designation as Executive Director. He added that despite the Board's action, he will continue to do the job and daily operations would continue. The Board took no action.

10. <u>Annual Meeting Schedule and Election Procedures.</u>

Mr. Marez stated that per State requirements, the Board must review Election Procedures for the Annual Membership meeting. The positions currently held by Mr. Escobedo and Mr. Hinojosa are up for election in April of 2022. He presented TRWA's Election Procedures 2021 Changes and reviewed the following recommended changes:

- 1. The COVID-19 letter has been updated with TRWA's current advice on holding meetings during the ongoing pandemic.
- 2. Language was stricken from page 4 of the TRWA Elections Procedures which previously allowed board candidates' personal information to be kept confidential.

He also presented the timeline and schedule for the 2022 Annual Membership Meeting and asked for approval to proceed with the schedule and to incorporate the recommended changes in the RWSC Regular Meeting Minutes December 1, 2021 Page 4

Corporation's Election Procedures. The Board reviewed the proposed schedule and the notice to members on submitting an application for the RWSC Board of Directors. Mr. Robertson made a motion to authorize incorporating the changes into RWSC's procedures, to approve mailing of the presented documents and proceed with the recommended schedule. Mr. Hinojosa seconded. All voted in favor.

11. <u>All matters pertaining to TxDOT Upgrades on US 77/I69</u>.

Mr. Marez presented documents supplied by TxDOT pertaining to the upgrades on US 77/I69. He reported that he has been communicating with engineers from LNV, TxDOT staff and Max Underground management on this project. The project is set to begin November 15, 2021 and expected to end by January 15, 2022. However, Max Underground has indicated that they will need three weeks for arrival of some material. TxDOT has indicated that this will not hinder the project as long as everything is in place by March 15th. No action was taken by the Board.

12. <u>TCEQ Notice of Total Trihalomethane Violation and public notification to customers.</u>

Mr. Garcia and other Board members stated that they had not received any complaints regarding the violation notice sent out to customers. Mr. Marez reported that the next samples will be collected on December 8th and Mr. Gomez added that some adjustments have been made at the pump stations and flushing is being performed more frequently but at lower volumes continuously throughout the month. TRWA also provided training recently and looked at the RWSC mapping and suggested tying into other waterlines to keep water flowing. Mr. Marez commented that O&M Supervisor Dony Cantu has resigned and Mr. Gomez is filling in for him until someone is hired.

13. <u>Update on repair of leak on transmission line on CR 1030 and update on replacement of line</u>.

Mr. Gomez reported that the area of the leak needs to be cleaned up once the ground is dry. He added that the property owner, Joe Garcia, has stated that he does not want the culvert but the neighboring property owner has indicated that he wants the culvert installed. Staff will add this to the schedule.

- 14. Update and discussion of RWSC Emergency Preparedness Plan.
 - <u>Ardurra Proposal for Engineering Services</u>

Mr. Marez stated that the documentation needed to complete the Emergency Preparedness Plan is extremely complex and many water providers have outsourced the task. He added that Ms. Wagner requested a bid from Ardurra for completion of the document. He presented Ardurra's quote in the amount of \$5,620 and recommended entering into the agreement. Mr. Escobedo made a motion to approve Ardurra's proposal in the amount of \$5,620. Mr. Robertson seconded. The motion passed unanimously. RWSC Regular Meeting Minutes December 1, 2021 Page 5

15. <u>Purchase of materials to build up RWSC stockpile of materials due to stagnation in PVC</u> production and transportation issues.

Mr. Marez reported that over the last few months, staff has noticed an increased cost and scarcity of materials in the water utility industry including shortages of PVC pipe, fittings, valves and similar materials. The Corporation's supplies remain in adequate amounts, but there is a delay of 1 ½ to 8 months in delivery of materials. He requested that the Board consider authorizing staff to look into purchasing materials to serve as a stockpile to ensure the availability of materials for repairs and other projects. He added that a Houston manufacturer is available to provide materials more quickly but at a steep price. The Board agreed that staff should move forward with researching cost and availability of material for presentation at a future meeting.

16. Adjournment.

With no further business to conduct, Mr. Hinojosa made a motion to adjourn the meeting at 6:26 p.m. Mr. Robertson seconded and all voted in favor.

Background:

This project consists of installing approximately 3,246 linear feet of 6-inch PVC waterline, steel casing, fittings, and gate valves along the right-of-way for Ricardo area including the areas near Chavez Road, Farm-to-Market Road 1118, County Road 2150 and US Highway 77 (Interstate 69). The construction contract was awarded to Max Underground (MU) in July 2021 for approximately \$400,000. Adurra/LNV (our engineer of record), TXDOT, Halff Associates, MU and RWSC have each maintained frequent communications to ensure this project is completed within the proper timeframe and budget.

Analysis:

The planning of this TXDOT required waterline relocate has been in the process for over two years. Initially this adjustment was projected to be complete in the January/February timeframe but due to supply chain issues the final completion date is set for mid-March.

Staff Recommendation:

Review the enclosures and receive any future updates on the progress and ultimate completion of the project. RWSC staff will continue to have an onsite presence throughout the construction to monitor and troubleshoot any problems or questions that arise. This approach has formed strong connections between all parties and allowed for quick responses to issues that could have prolonged the construction timeframe.

Board Action:

No action is needed since the board has already approved this item and staff are now working with our engineer, TXDOT and contractor to complete the waterline adjustment.

Summarization:

This item is for review only but allows the board an opportunity to receive a full update of the timeline and scope of the project. Our staff will be available to discuss any further items in detail during this month's board meeting. Other than unforeseen weather problems we anticipate completion no later than March 17th.

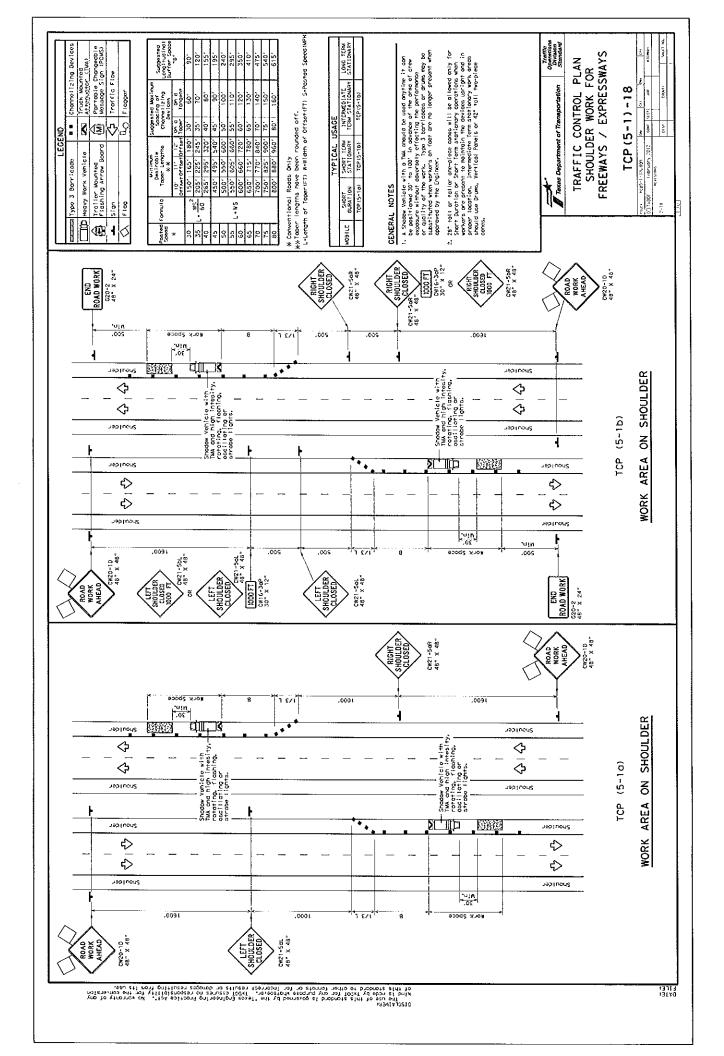

This has been a practical use since it allows staff to use only one formatting type instead of several reiterations. During the January 25th board meeting of the STWA their board approved and accepted the use of a company that specializes in Rural Water Company websites.

Analysis:

Using the same website design allows for the RWSC to maintain their own individual website and be able to modify messages, reminders or notices to the public in real time. Our staff will be able to make these adjustments from any location at any time of the day or night and will no longer require staff to come into the office to change these messages. This proposed site allows for all costumers to sign up for email and/or text message notifications of any water boils, office closures, bad weather, etc. The proposed cost is estimated at \$702.75 although the final price could slightly fluctuate.

Staff Recommendation:

Approve a motion to allow Rural Water Impact provide the website design services for the RWSC and match the STWA design as well. Should all three corporations use this company a slight discount will be provided on the year one cost as listed earlier.

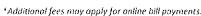

My contract as administrator for the STWA began on August 2, 2021. This was the same day as the most recent meeting was held for the NWSC. As with all transition there will be opportunities to modify and learn the preferences of communication for the three boards which I serve. This memo and corresponding agenda item is created to allow the Board to share their preferences and expectations for communications when it comes to the day-to-day operations, budget updates and reports of incidents/emergencies. This communication plan will include various methods of communication by staff for the board including the following: in-person, print, electronic, phone calls and text messages.

Analysis:

This overall plan includes three areas or types of Communication to be expected and keep you informed throughout the course of operations: Routine Communication, Budget Communication and Risk/Incident Communications.

<u>Routine Communications</u> will include information about how and when day-to-day communications will happen. The Management Team will provide updates of tasks/project status when individually or Board requested. Based on how most Board/Manager models operate a step-by-step or extremely detailed accounting of the day's events tend not to be practical since staff are busy actually carrying out those duties but if the Board request, additional information will be provided.

<u>Budget Communications</u> will include information about how to keep the Board information of the overall budgeted costs versus the actual cost. In addition, these communications will show how staff are working to remain within the NWSC adopted budget throughout the year.

<u>Risk/Incident Communications</u> are the most difficult of all. With today's speed of receiving notification by social media or text message, information about a particular incident can potentially reach you faster than any formal/official notice given by staff. This is not and excuse to not provide responsible updates but only to state that we will work hard to ensure your updated about a situation as soon as we are. In addition, I am currently in the process of creating templates and other methods of communications to have ready at a moment's notice to keep you updated.

Staff Recommendation:

Staff and myself will work to ensure your request for information are met and provided in a timely matter. We will each work to provide you with updates regarding daily items but will especially focus to keep you informed during incidents that include emergency response or repairs that impact the NWSC or the larger STWA water system.

Re: Purchasing Stockpile of Materials for Field Operations

Background:

Throughout the COVID19 Pandemic various supplies of materials have been in limited stock including foods and paper products to name a few. Matching that trend, we have observed over the last several months a scarcity of materials in the water utility industry with shortages of PVC pipes, fittings, valves, etc. This is based on the reduced production of petroleum-based products which translates to reduced manufacturing and ultimately rising cost for materials we use to repair water lines or new/existing connections.

While our supplies remain in adequate amounts staff has noticed longer wait times for ordering materials that that in some cases are estimated to take a one and a half $(1 \frac{1}{2})$ to eight (8) months delay in receiving those materials.

Analysis:

All current projects show a continued slow-down of material output for the foreseeable future. This trend also corelates with an increase of materials cost. Immediate action is recommended to gain a substantial amount of supplies to address the corporation's needs.

Staff Recommendation:

Staff recommends purchasing materials to serve as a stockpile to counter the current trends of delays in transporting supplies, decreasing amounts of materials and increasing cost.

Board Action:

Provide staff guidance to purchase materials to ensure the RWSC has an adequate stockpile to respond to daily needs, emergencies and small projects.

<u>Summary:</u>

Due to various factors out of our control, the RWSC faces a possible shortage of materials to fix daily repairs or emergencies. In addition, without an adequate supply of PVC pipe, fittings and values places our crews in a bind to provide immediate relief for the member's emergency or everyday needs. Selecting an amount for stockpile will better ensure that the RWSC has enough resources on hand to fix most, if not all, problems that arise.

Re: Report on Drone Inspections

Background:

The RWSC received an offer for free drone services from a Ricardo resident who recently opened a company offering aerial photography in September 2021. After much coordination between the Badbird Aerial Data company our staff were able to set up a date for Mr. Perez to provide his services. President Garcia, along with myself and some of our field staff were present during the capturing of this aerial data. Mr. Perez's company can provide more detailed photography for all of our RWSC towers and property at a rate of \$500.

Analysis:

Review the sample photographs and determine if these services are desired and if so during the April board meeting provide an action item to approve an agreement.

Staff Recommendation:

The current 2022 Fiscal Year budget did not account for these services. These services save man hours climbing the tower to get a full rendering of our property and without placing staff or contractors in peril to avoid working at those heights.

Board Action:

Review the photographs and plan for a budget item next year to accommodate these services.

Summarization:

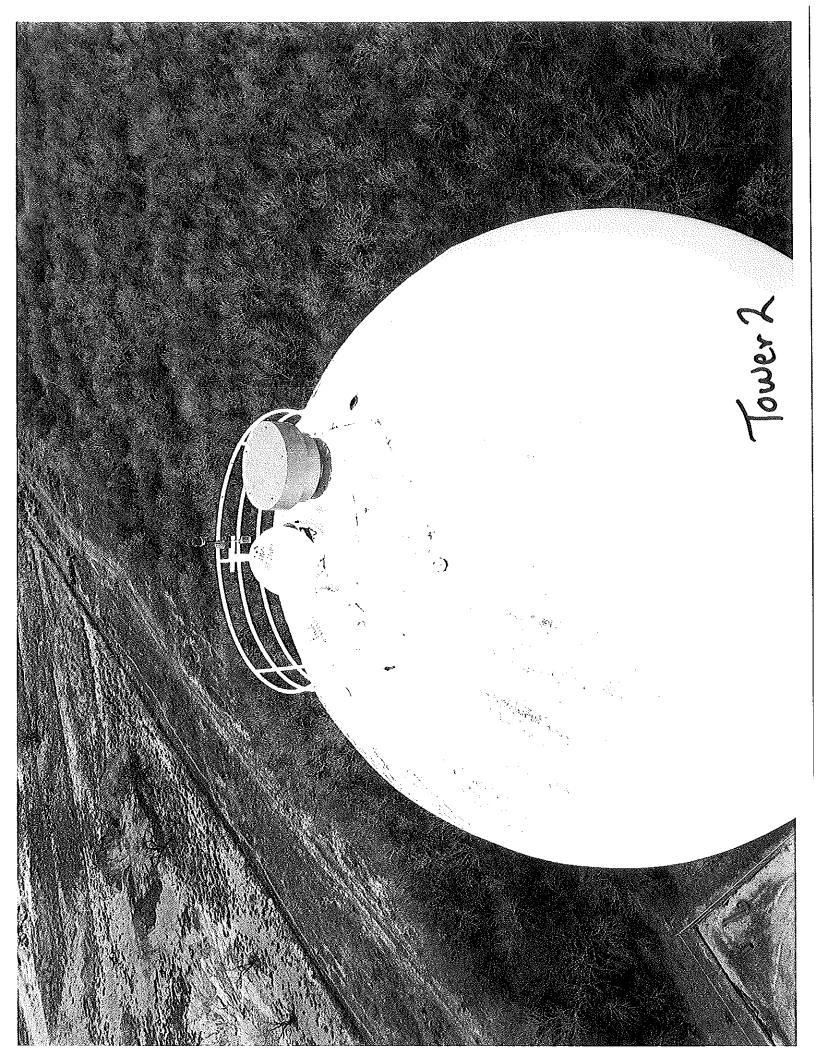

GENERAL INSTRUCTIONS

What is a Photo License Agreement?

A photo license agreement is a legal contract where the owner of a photo licenses the use of the image to a person or company. The original owner retains the copyright of the image. The contract stipulates the terms on how, when, and where the licensee can use that photograph. In the photo licensing agreement, the licensor is the person who owns the copyrights or is licensing rights to use the image. The licensee is the person who is gaining the rights to use the image.

In a photo license agreement, the copyright is not being sold -- the licensee is essentially licensing the right to use it, not own it. If you're an independent photographer, the copyright for an image belongs to you as soon as you take the picture. However, if a photographer is working through a company in a work for hire arrangement, the copyright may belong to the company.

In short, you need to hold the copyright in order to license the work to another party.

When Do I Need One?

Holding a copyright to a photograph doesn't produce any income in itself. A photographer may charge a session fee or other fees associated with a shoot. If a photographer takes photos where they retain the copyright, developing a photo licensing agreement to sell usage to clients becomes an excellent way to earn revenue from the work.

A photo license agreement protects both the copyright holder and the person who wishes to publish or use the image. This contract stipulates what the image is, how it can be used, and whether the licensee can manipulate the image.

An agreement is generally discussed prior to the sale of the licensing rights. There are different terms and conditions which may be applicable. Both the licensor and licensee should be in agreement on the scope of the agreement.

The copyright owner will often set the price for

the price may be set far higher. In comparison, a non-exclusive license where the copyright holder might license the same work to multiple parties can produce more sales and be priced more moderately.

The Consequences of Not Having One

A photo usage license agreement protects both the copyright holder and the person licensing the work.

Here are a few consequences that can arise for the copyright holder without a photo licensing agreement:

- Lack of revenue
- Lack of control

Possible consequences for the licensee include the following:

- Inability to use the image
- Inability to keep others from using the image

The Most Common Uses

A photo licensing agreement is generally used when a photographer wants to license his or her work for use without selling the copyright to the image. In this way, the photographer still gets credit for the image and they will get paid for its use.

What Should Be Included?

Depending on the scenario, a photo usage licensing agreement might be very simple or it can contain elaborate terms and restrictions. Here are some of the things that should be included in the agreement:

- The parties
- Exclusive or non-exclusive
- The fee or payment
- Permissions
- License period
- Limitations

Background:

During the December 6, 2021 meeting the board approved entering into a professional services contract with Ardurra/LNV to complete the state mandated EPP also known as Senate Bill 3 (SB3). SB3 was created in response to Winter Storm Uri which took most Texas utilities off-line and presented lift threatening situations for the customers of electric, water and wastewater providers. The principal response to SB3 was to require that all Texas utilities file with their Electric providers for "Critical Load Status" allowing each, priority to receive electricity first for any future infrastructure disasters. The current documentation needed to complete these forms are extremely complex with most water providers seeking to outsource this time-consuming task. The RWSC through our Finance Manager sought an outside bid from Ardurra to complete the 40 plus page (Emergency Preparedness Plan) EPP document to submit to TCEQ no later than March 1, 2022.

Analysis:

The EPP is a time-consuming form that many utility providers are outsourcing since staffing levels cannot devote enough time for this sole responsibility. Using an outside firm will free up time and resources to allow the RWSC staff to focus on their regular essential jobs. This bid amount is on par with other companies offering similar bid estimates.

Staff Recommendation:

Receive Adurra's finalized EPP report submitted to the Texas Commissioner on Environmental Quality.

Board Action:

Review the attached report. Staff will be available to answer your questions during the board meeting.

Summary:

Adurra completed a highly technical form for the TCEQ on behalf of the RWSC by March 1, 2022. This Senate Bill was signed into law in 2021 in response to Winter Storm Uri's impact on utilities throughout the state. This form will help the RWSC reconnect with our electric providers at a faster rate to previous and guarantees prompt water services for the customers.

Staff Recommendation:

Staff recommends entering into agreement with Adurra for \$5,620 to complete the form to be submitted to the Texas Commissioner on Environmental Quality.

On June 8, 2021, the 87th Texas Legislature passed Senate Bill 3 (SB 3) that created Section 13.1394 in the Texas Water Code (TWC) which requires affected utilities to provide emergency operations of their water system(s) during extended power outages lasting more than 24 hours. Based on Texas Commission on Environmental Quality's (TCEQ) records, RICARDO WSC meets the definition of an affected utility. As an affected utility RICARDO WSC is required to submit an Emergency Preparedness Plan or EPP to the TCEQ no later than March 1, 2022. The EPP is required to be implemented no later than July 1, 2022 or upon final approval by TCEQ.

TWC Section 13.1394 defines an "affected utility" as a retail public utility, exempt utility, provider or conveyor of potable or raw water that provides water service to more than one customer and is not an affected utility under Section 13.1395. Affected utilities are required to develop an EPP to restore the water system's minimum operating water pressure of 20 pounds per square inch (psi), whenever a power outage lasts more than 24 hours. The law requires water systems with residential customers or that provide overnight accommodations at their facility, to provide water service during extended power outages of 24 hours or more.

The TCEQ has designed a template that can be used to develop an EPP. Information, instructions, and the TCEQ's EPP template (form number TCEQ-20536B) can be found at the following weblink: <u>www.tceq.texas.gov/goto/epp</u>.

If providing emergency operations will cause a significant financial burden to your customers, you may request a financial waiver. Information on requesting a financial waiver is located at the following weblink:

Submitting a waiver request does not waive the requirement to submit an approvable EPP if your waiver request is denied.
