A motion was made by Mr. Escobedo and seconded by Mr. Garza to approve the Treasurer's Report and payment of the bills. The motion carried.

#### 5. RWSC Annual Membership Meeting.

- Selection of Election Auditor
- Approval of agenda and meeting packet for Annual Membership Meeting
- Resolution 20-01. Resolution declaring unopposed candidates of Ricardo Water Supply Corporation elected.

Ms. Serrato reported that three nominations were received by the February 18<sup>th</sup> deadline. She added that since there are three positions up for election, the Board can adopt Resolution 20-01 declaring the three candidates, Baldemar Garcia, Robert Garza and Timothy Robertson, elected. If adopted by the Board, Resolution 20-01 will be read into the record at the Annual Membership meeting on April 14<sup>th</sup>. She also explained that because no election will be necessary, an Election Auditor does not need to be selected. She presented the meeting notice and agenda for the Annual Membership Meeting and recommended approval of the documents which need to be mailed out by March 13<sup>th</sup>. Mr. Robertson made a motion to adopt Resolution 20-01 and approve the meeting notice and agenda. Mr. Escobedo seconded and all voted in favor.

#### 6. All matters pertaining to TxDOT Upgrades on US 77 at CR 2120/FM 772 and US77/I69.

Ms. Serrato presented the advertisement for bid on the project and stated that she expects the project to move quickly once the bids are opened. She added that service should remain available to customers during the project since a pass-through agreement exists with the City of Kingsville. She also reminded the Bord that the cost will be reimbursable once the Corporation's part is complete. No action was taken by the Board.

#### 7. Quotes for painting of elevated storage tank at Pump Station #1.

Ms. Serrato stated that after contacting some companies about a quote for painting of the elevated storage tank at Pump Station #1, only Diamond Enterprise and Texas Tank Service provided quotes. Each of them provided quote for two options which varied from \$96,500 to \$157,000 for the less expensive option without warranty and \$202,580 to \$252,900 for more expensive options which should last longer and include a warranty. The Board decided to wait on painting until reimbursement is received for the TxDOT project. Mr. Garcia stated that maybe by then, one of the other companies might be available to provide a quote.

#### 8. Ricardo Volunteer Fire Department Water Usage.

Mr. Garcia stated that he had been made aware of several fires in the Ricardo area that required use of water by the Ricardo Volunteer Fire Department. He stressed the importance of accounting for the usage and said that the Kleberg County Judge had previously instructed the RVFD to report use to RWSC. He added that the RVFD meets on Thursdays and asked that a Board member try to contact the Fire Chief at the meeting to make them aware that the usage is not being reported. Mr. Garza said that he would try to find out who the Fire Chief is and Mr. Escobedo and Mr. Fischer stated that they would try to go by the Fire Department's meeting. No action was taken by the Board.

9. NEC Power Factor/Demand Charge and quote from C.C. Electric for Variable Frequency Drive Controllers and Motors at Pump Station #1 and Pump Station #2.

Ms. Serrato reported that NEC has begun assessing a demand charge for customers with a power factor less than 95% which has resulted in an increase in electric charges. She received information from NEC that a capacitor could be installed between the motor and controls to correct the problem. However, the electric company familiar with the pump stations has indicated they would not be able to provide a quote. Staff contacted Corpus Christi Electric Company and CD Electric about possible ways to correct the problem but the quotes received are very costly. Ms. Serrato stated that no action is required at this time but she wanted to make the Board aware of the situation.

#### 10. Adjournment.

With no further business to conduct, Mr. Hinojosa made a motion to adjourn the meeting at 6:02 p.m. Mr. Robertson seconded and all voted in favor.

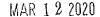

#### Background:

Since the last meeting, a number of activities have occurred: the bid advertisement for the CR 2120 – US 77 project was published, a pre-bid conference was held, a bid opening occurred, the engineer's recommendation was provided, the bid was awarded to Bridges Specialty, Inc. (Bridges) and a preconstruction remote meeting was held. The selection of the lowest *responsible* bidder required some additional research and consultation with TxDOT. The company submitting the lowest bid was not selected due to a lack of experience. Enclosed are emails sent to the Board regarding this project.

Also enclosed is a TxDOT notice regarding a new section which encompasses the RWSC's service area from CR 2130 to CR 2230. In addition to my email response regarding previous communication that RWSC would not be affected by TxDOT's upgrades in this expanse, Armando Yruegas and I spoke with Leonel Tovar, TxDOT, regarding the initial TxDOT meetings and the configuration of the highway particularly as it pertains to whether or not additional right-of-way was being purchased. Mr. Tovar confirmed that additional right-of-way had not been purchased; however, there would be ditch line work and the depth of perpendicular and parallel waterlines could be a factor.

#### Analysis:

With regards to the CR 2120 project, Bridges should be providing their submittals and the contract documents should be signed shortly. During the preconstruction conference, Bridges indicated that the longest wait will be associated with receiving the made in USA steel products for the new line's casing.

With regards to the new TxDOT notice, four (4) sets of plans were taken to Arc Printing for the plans to be digitized. Staff will be pulling permits for three (3) out of the four (4) crossings that may be impacted by a modified flowline. The fourth crossing may prove difficult to locate. It is the FM 1118 crossing shown in the 1964 plans. The crossing immediately south of FM 1118 is located within the easement recently acquired from William Dean Radford as part of the Dollar General project. The other two crossings are at CR 2170 and FM 772 South. During our conversation with Mr. Tovar, he indicated that Subsurface Utility Engineering (SUE) work had been done previously and that information would be provided. Further, he indicated that TxDOT would work with RWSC to minimize impacts to waterlines.

#### Staff Recommendation:

Keep the Board updated on both TxDOT project sections. Continue to work with LNV and TxDOT.

#### **Board Action:**

Provide feedback to staff.

#### **Summarization:**

Staff will work to minimize the impact of the latest project section on RWSC's four (4) highway crossings and the parallel line extending from FM 1118 to CR 2150.

#### Good Afternoon RWSC Board,

The bid opening for the TxDOT highway crossing was held at 2 pm today. The apparent low bidder is a company by the name of Costa Verde Resources LLC. The bid amount was \$193,425.

Hector Castaneda with LNV, who conducted the opening, thought it would take a few days before Eric Villarreal, LNV, has a recommendation. It appears that the correct forms and bid security were provided. However, LNV will check on the company's references to ensure they are capable of performing the job.

There were a total of six (6) bids with a high bid of \$462,610 and three of the bids in the \$260k to 270k range. The second lowest bid was from a company called Bridges Specialty Inc in the amount of \$220,570.

At this time, we have heard that TXDOT personnel are working out of their homes. I have not received an email from Leonel Tovar, TXDOT for about a month inquiring about projected date to begin. Regardless, the next step will be a preconstruction conference and typically a "notice to proceed" will be issued at that time. The Board will recall that a resolution was signed allowing the Board President and GM to execute the necessary paperwork to keep the project moving forward. As such, some of these steps may already be underway when the Board meets on April 14<sup>th</sup>.

Finally, with regards to the Annual Meeting and next Board meeting, this morning the Texas Rural Water Association (TRWA) issued a notice to its membership in light of the COVID 19 situation. At this time, they are still recommending holding Annual Meetings to remain in compliance with State requirements. They advise to make the meeting as brief as possible and advise members not to bring additional guests. In many cases, WSC annual meetings are somewhat elaborate occasions with meals, etc. With regards to complying with the Open Meetings Act, TRWA is advising that Governor Abbott signed an order which would allow for telephone and video conferencing to hold a meeting without all required members gathered in the same room. There are some detailed requirements, however; I will be discussing these with Bill Flickinger since STWA has a meeting next Tuesday.

#### RWSC Board,

In follow-up to the previous email. A recommendation has been made by the engineer to award the bid to the second lowest bidder. This is as a result of the lowest bidder failing to show proof of the necessary experience to perform the job. As such, it is being awarded to the lowest, qualified (responsible) bidder. Eric has consulted with TxDOT on the matter and the result is the attached letter of recommendation.

I cannot be certain; however, it is possible that the contracts may be executed by the Annual Membership April 14<sup>th</sup> meeting date. I spoke with Mr. Garcia about the need to still hold the meeting. Although the Governor has eased the requirements for elections, the Order does not apply to WSCs and the meeting needs to occur. In addition, the meeting after the Annual Membership meeting will also be needed. More information on the project should be available by that date.

In addition, there will be information to share on the status of operations due to COVID-19. As discussed with Mr. Garcia, the TCEQ and legal counsel have advised to suspend disconnections of service. As such, the lockouts that would normally occur tomorrow will not happen. However, legal counsel is advising not to be broadcasting this news since RWSC still wants its customers to pay their bills. Although personnel are still reporting to work, foot traffic ceased as of this Monday, March 23<sup>rd</sup>. Payments are being accepted by the drop box; but, we are no longer accepting cash and face-to-face transactions are not occurring. Legal counsel has advised to continue trying to process applications for new service using email and regular mail again avoiding any face-to-face contact. More information on these subjects will also be available by April 14<sup>th</sup>.

THIS CONTRACT, is between the Ricardo Water Supply Corporation, A Texas non-profit corporation, (hereinafter called RWSC) and Cesar Silva., (hereinafter called Developer).

#### WITNESSETH:

WHEREAS, RWSC has a contract with South Texas Water Authority, a governmental agency, conservation and reclamation district and body politic and corporate, to obtain water for supply to areas which lie outside of the jurisdictional limits of the other existing incorporated cities, water districts, or other municipal corporations which lie within the boundaries of South Texas Water Authority; and

WHEREAS, the South Texas Water Authority has an agreement dated October 14, 1980, with the City of Corpus Christi to obtain treated water from the City of Corpus Christi which gives the South Texas Water Authority the capacity to serve customers lying within the established boundaries of the South Texas Water Authority; and

WHEREAS, both RWSC and Developer recognize the terms of this contract are subject to all the terms and conditions of the contract between the City of Corpus Christi and South Texas Water Authority as well as the contract between South Texas Water Authority and RWSC, and incorporate the terms of each of said contracts by reference into the instant contract; and

WHEREAS, Developer desires to obtain a commitment from RWSC to supply water to a subdivision, as hereinafter described, which Developer has platted; and RWSC desires to supply water to such subdivision under the terms and conditions as hereinafter stated.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, RWSC agrees to supply water under the terms and conditions and for the considerations hereinafter set forth, to-wit:

- From and after the effective date of this agreement specified in paragraph 5 below,
   Developer shall have the right to have water supplied to Developer's subdivision by RWSC in Kleberg County, Texas at a point described and depicted in Exhibit A, attached hereto and incorporated herein by reference.
- 2. Water provided by RWSC shall be exclusively used within the service area described in Exhibit A, referred to above. Developer warrants and certifies that the described area within which said subdivision lies neither wholly nor partially within the jurisdictional area of an existing city, municipal corporation, water improvements district or water control and improvement district which have a prior right to supply water to the subdivision, but are situated completely within the boundaries of South Texas Water Authority and within the area served by RWSC.
- 3. RWSC makes no guaranty that water will be available at any particular time or place; it being fully understood by both parties hereto that the ability of RWSC to supply water is subject to its contract with South Texas Water Authority which is subject to South Texas Water

Authority's contract with the City of Corpus Christi for the supply of water, all terms of both agreements being herein incorporated by reference, and that this instrument is merely an agreement to allow withdrawal of water from the system operated by RWSC, when and if same is present and available.

- 4. As a precedent to RWSC having a duty to supply water to Developer's subdivision, Developer must:
  - (a) meet all flood plain, platting and subdivision requirements of the contract between the City of Corpus Christi and South Texas Water Authority and the contract between South Texas Water Authority and RWSC as well as local city, county, state or federal ordinances or laws and by the Federal Grant and Loan Agreements of which South Texas Water Authority and RWSC are subject as shall be specified by RWSC;
  - (b) make a deposit sufficient as determined solely by RWSC, to pay for the oversizing of the line(s) and/or increased pumping capacity necessary to service the subdivision as reasonably required when fully developed as platted; such deposit to be made prior to the servicing of said subdivision. Upon Developer having met all requirements, including payment for the increased capacity of the water system as stated hereinabove, RWSC shall have the duty to provide water to the subdivision to the extent of the increased capacity, as needed by the subdivision. If at the end of seven (7) years from the date water service first became available to the subdivision, such increased capacity is not being fully utilized for service of the subdivision, from such

time RWSC, South Texas Water Authority or the respective assigns of either, shall have the right to allocate the use of such excess capacity for other customers.

Developer, during such seven (7) year period shall not be entitled to the exclusive use of such increased capacity unless or until all of the increased capacity is actually required in order to serve the subdivision or development.

- (c) submit for RWSC review and approval, all plans and specifications for water improvements within the development prior to construction. The Developer shall conform with all material and construction specifications of South Texas Water Authority and RWSC for water system improvements within the development prior to construction.
- (d) notify RWSC prior to the beginning of construction of the water distribution system within the subdivision so that RWSC may inspect the work in progress.
- (e) upon completion of construction of the water distribution system within the subdivision, submit as-built drawings and dedicate the water system improvements and an easement twenty feet (20') in width (or ten feet [10'] if the easement is adjacent to a public road or street) conforming to the outlines of the water distribution system as reflected by the said plat and as-built drawings, to RWSC or its assigns after final inspection and approval by an authorized representative of RWSC.
- This agreement shall not be considered effective or a binding obligation against RWSC until Developer has made all deposits and met all requirements called for by this Agreement.

- 6. Subject to Developer's duty to pay for the increased capacity of the line as stated hereinabove, RWSC will provide water service to the boundary line of the subdivision. Developer shall be financially responsible for the construction of the water distribution system within the subdivision.
- 7. RWSC will neither accept the dedication of the water system improvements nor provide water to the subdivision unless at the time of the dedication by Developer, Developer also submits to RWSC on forms supplied by RWSC, an affidavit executed by each contractor and subcontractor who has either supplied materials or labor to Developer for the construction, that contractor or subcontractor has been paid for the work performed, as well as an affidavit by Developer that Developer has paid for all work and materials supplied for the construction of the water system improvements.
- 8. Developer shall have no right to sell water to purchasers of lots within the subdivision and understands and agrees that each property owner within the subdivision will sign an individual water service contract with RWSC, or its assigns, before water service will be provided to the property owner desiring service.
- 9. Any expansion of the subdivision beyond the boundaries as shown by the plat attached hereto as Exhibit B will require that the Developer enter into a new water supply and development standards contract with RWSC, or its assigns, containing generally the same provisions as the instant contract.

- 11. In further consideration of RWSC's agreement to provide water to the boundary line of the subdivision, Developer warrants and covenants that:
  - a. Developer is the owner of record of the land described in the plat attached hereto as
     Exhibit B.
  - b. The name of the subdivision is Silva Estates.
  - c. The entire land contained within the subdivision and for which Developer enters into this Water Supply and Development Contract is described on a subdivision plat attached hereto as Exhibit B.
  - d. The land contained within the subdivision is held by Developer under deed recorded in the Deed Records of the Kleberg County Clerk's office as follows: Envelope 165.
  - e. All taxes which are liens on the land at the date hereof have been paid.
  - f. There (are) (are not) any encumbrances or liens against the land. (Specify encumbrances, if any.)

- 12. Developer will indemnify and save RWSC harmless from any and all claims or demands whatsoever to which RWSC may be subjected by reason of any injury to any person or damage to any property resulting from or in any way connected with any and all actions and activities (or failure to act) of Developer under this contract. Developer shall be solely responsible for obtaining any permits or easements for the use of land owned by others, if necessary for the construction and installation of the water system improvements within the subdivision. However, nothing in this agreement shall be construed as authorizing Developer to obligate RWSC in any manner related to the installation and construction of any equipment, materials or water system improvements either within or without the subdivision. Developer further hereby releases RWSC and agrees to hold it harmless from any and all claims that Developer has or may have against RWSC for any reason whatever resulting from the agreement to use water obtained from RWSC, and RWSC makes no representation as to the quality of such water, other than it shall be potable.
- 13. No assignment of this agreement in whole or in part for any purpose shall be made or granted by Developer without the prior written consent of RWSC.
- 14. This contract may be changed or modified only with the written consent of Developer and the governing body of RWSC. Such modification may be requested by either party, but shall not in any event be effective until approved by the Board of Directors of RWSC.
- 15. This contract shall be subject to all valid rules, regulations and laws applicable hereto, past, or in the future, promulgated by the United States of America, the State of Texas, and any

other governing body or agency having lawful jurisdiction, or any authorized representative or agency of them.

- 16. If RWSC should be prevented, wholly or in part, from fulfilling its obligation to supply water to the boundary of the subdivision, by reason of any act of God, unavoidable accident, acts of enemy, strikes, fires, floods, conservation of water for those with superior and legal rights to such water, governmental restraint or regulation, or other causes of force majeure, or by reason of circumstances reasonable beyond its control, then the obligation of RWSC to deliver water to Developer's subdivision, as hereinabove provided, shall be temporarily suspended during continuation of such force majeure. No damage shall be recoverable by Developer from RWSC by reason of the temporary suspension of delivery of water due to any of the causes above mentioned. If RWSC's obligations shall be affected by any such causes, RWSC shall promptly notify Developer in writing, giving full particulars of such force majeure as soon as possible after the occurrence of the cause or causes relied upon.
- 17. It is agreed by the parties hereto that this instrument contains in writing all of the agreements between the parties hereto and nothing (except those things required by law) not incorporated herein or by reference shall be binding on the parties.

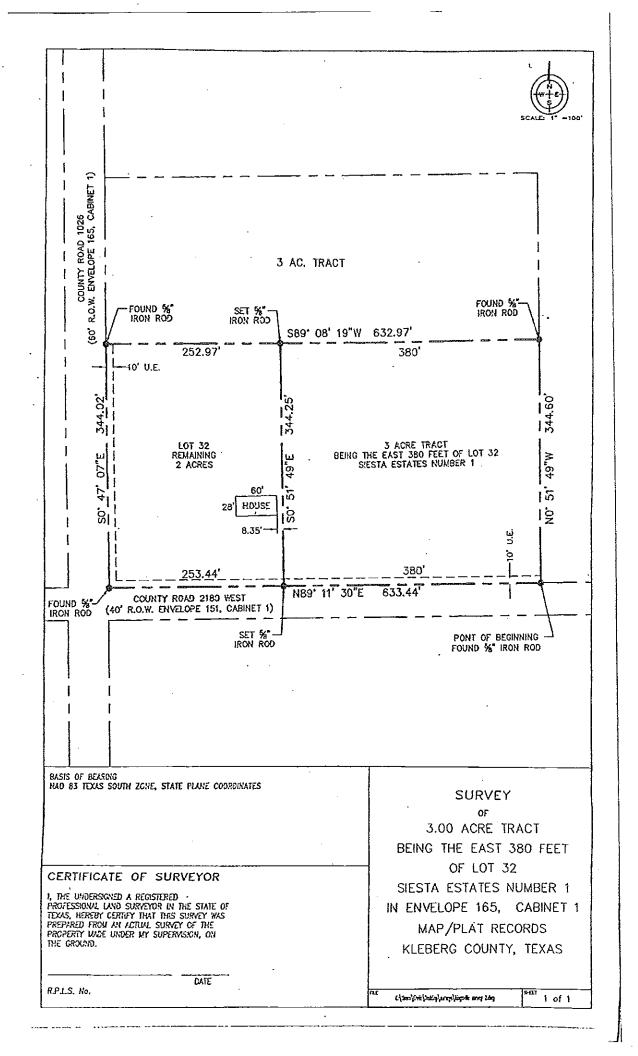

Lot 32 Siesta Estates Number 1.

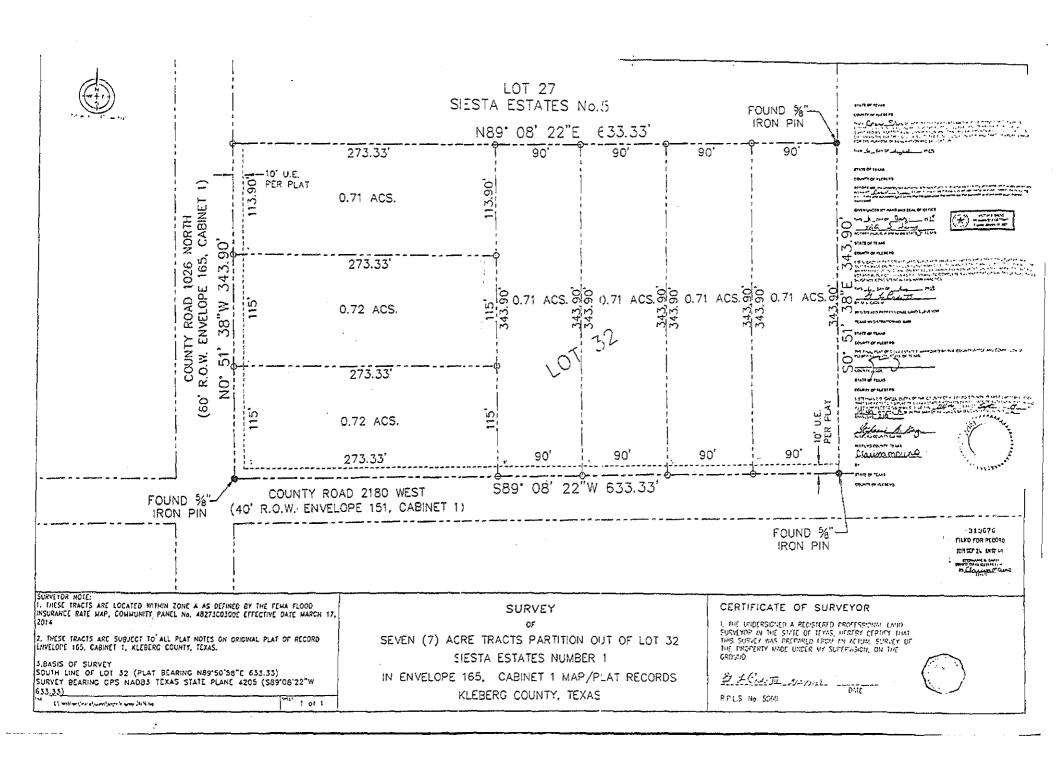

Once the water lines and extension are installed, title passes to the Corporation. Thereafter, operation and maintenance of the line or extension will be the Corporation's sole responsibility. All lines on the property owner's side of the Corporation's meter are the member's responsibility. Payment in full of the Pro-rata fees must be received prior to providing water service to any lots in the replat of Lot 32, Siesta Estates #1 subdivision.

As a participating developer, your subdivision is permitted six (6) service connections at a cost of \$980.00 per connection, which includes a developer discount of \$300.00 applied to the standard cost of \$1,280.00. There are no rebates or refunds to the developer as lot owners are serviced. All lot owners must apply for service and pay fees before service is provided.

This subdivision falls entirely within the FEMA (Federal Insurance and Mitigation Administration) FIRM (Flood Insurance Rate Map) - Zone A. Therefore, in accordance with requirements in the USDA loan agreement with RWSC an elevation certificate for each home being built on each lot must be obtained prior to RWSC providing service. Elevation certificates are administered by Mr. Tomas Sanchez, Kleberg County Emergency Management Coordinator and Flood Plains Administrator. His office is located in the Kleberg County Courthouse Basement, Room B-126. A copy of the approved certificate must be provided to our office for each lot.

Finally, enclosed for your signature is a developer's contract. Please sign the contract and return it with a copy of the recorded plat. # Ricardo Water Supply Corporation Cost Analysis to serve six connections on property located on CR 2180 and CR 1026, replat of Lot 32, Siesta Estate #1,

The purpose of this analysis is to determine the estimated cost for the Ricardo Water Supply Corporation (RWSC) to provide water service to 6 lots in the subdivision located on CR 1026 and CR 2180. The cost for providing service will include a pro-rata share of the existing improvements, any new improvements, and any engineering costs incurred.

The first step of the cost analysis will estimate the pro-rata share of RWSC's existing improvements that are impacted by your service request. The improvements impacted are Pump Station #1 and the water distribution system to your property. The four projects that have costs associated with these improvements are RWSC Water System Improvements Phase 2 (1988), Water System Improvements (1996), 2002 Overhead Tower Construction, and the addition of a liquid ammonia sulfate disinfecting system, 2005.

Based on the information provided, the property will have 6 connections. The pro-rata share of the existing improvements will be based on the 6 connections for the Subdivision divided by the total capacity of the improvements times the cost of the improvement.

In reviewing the Texas Commission on Environmental Quality (TCEQ) "Rules and Regulations for Public Water Systems," the following capacity criteria will be used to determine the total capacity of the RWSC Improvements.

- Capacity criteria for hydropneumatic tanks are 20 gallons per connection.
- Capacity criteria for 150,000-gallon overhead tower is 100 gallons per connection.
- Capacity criteria for service pumps are 0.6 gallons per minute (gpm) per connection.
- Capacity criteria for 2-inch water lines are 10 connections.
- Capacity criteria for 2.5-inch water lines are 25 connections.
- Capacity criteria for 4-inch water lines are 100 connections.
- Capacity criteria for 6-inch water lines are 250 connections.
- Capacity criteria for 8-inch water lines are 400 connections.
- Capacity criteria for 10-inch water lines are 650 connections.
- Capacity criteria for 12-inch water lines are 900 connection.

The following is the calculations of the pro-rata share of RWSC's existing distribution system that is impacted by the Subdivision.

#### A. Pump Station No. 1 (CR 2160)

- 1. Phase 2 Improvements at Pump Station No. 1 include the following:
  - a. 2-500 gallon per minute service pumps,
  - b. chlorination feed system and miscellaneous piping
  - c. electrical and control improvements.

## 2. Liquid Ammonia Sulfate Disinfecting System, 2005

Phase 2 – Pump Station Improvements	\$ 45,730.49

The costs of the Improvements for Pump Station No. 1 were \$64,995.49.

The capacity of Pump Station No. 1 based on the service pumps is 1,667 connections (2 pumps x (500 gpm capacity each / 0.6 gpm per connection). For this analysis, the capacity of Pump Station No. 1 is based on the two service pumps that will be used to calculate your pro-rata share. The pro-rata capacity of the Phase 2 Improvements for the 6 lots is 0.36% (6 connections/1,667 connections). The pro-rata cost of the Phase 2 Improvements for the lots is \$233.98 (0.0036 x \$64,995.49).

3. 2002 Overhead Tower Construction (150,000-gallon capacity)

The costs of the Overhead Tower Construction were \$269,100.00. The capacity of the Overhead Tower is 1,500 connections (150,000 gallons / 100 gallons per connection). The pro-rata capacity of the Overhead Tower for the subdivision is 0.40% (6 connections / 1,500 connections). The pro-rata cost of the 2002 Improvements for the (6) six lots is \$1,076.40 (.0040 x \$269,100.00).

#### B. Distribution System

1. 1996 Water System Improvements

The costs of the Improvements include the total cost of all items associated with the distribution lines. The following is a list of the items and associated costs for the Improvements that are impacted by the connection of the subdivision:

12-inch water line from Pump Station #1 on CR 2160 to CR 1040.

8-inch water line along the west side of CR 1040 to CR 2170 south and then west to CR 1030.

The capacity of the 8-inch line is 400 connections. The pro-rata capacity of the 1996 Water System Improvements for the subdivision is 1.50% (6 connections / 400 connections). The pro-rata cost of the 1996 Water System Improvement, 8" Distribution line is \$547.88 (.0150 x \$36,525.00).

4-inch water line on CR 2170, from CR 1030 west to CR 1026 and then south to CR 2180 and east to stake location on CR 2180.

The capacity of the 4-inch line is 100 connections. The pro-rata capacity of the 1996 Water System Improvements for the subdivision is 6% (6 connections / 100 connections). The pro-rata cost of the 1996 Water System Improvements is \$646.17 (.06 x \$10,769.44).

### C. Engineering Cost

The Engineering costs for determining the costs of the pro-rata share of the existing system to serve (6) six connections on your property is \$400.00. This cost is split as such, \$300.00 in-house capacity analysis and \$100.00 for the analysis review by Mr. Aaron Archer, Walker Partners, Inc.

The total of all estimated costs (excluding membership, tap fees, and service lines for individual customers) for the Ricardo Water Supply Corporation to provide water service to your lots on CR1026 is \$3,028.33(\$233.98+\$1,076.40+\$123.90+\$547.88+\$646.17+\$400.00)

Re: COVID-19 Response and Operation Changes

#### Background:

As the Board is aware, in response to the COVID-19 pandemic. significant changes occurred in how business was conducted during March of 2020. On Monday, March 23<sup>rd</sup>, our office was closed to foot traffic. In addition, we ceased to accept cash payments. Signs were posted at the front gate and on the drive-through window explaining payments were accepted by mail or in the drop box in the form of personal checks, cashier's checks or money orders.

In addition, on March 30<sup>th</sup> the Receptionist/Clerk, Billing Clerk, Accountant Assistant and Part-Time Clerk began working remotely from home. Arrangements were made for remote access to computers and call forwarding of specific lines to their personal phones. Arrangements are being made for mail to be delivered to a secure, rural mail box which is large enough to handle both Corporations' mail as well as South Texas Water Authority's mail.

During this time frame, both the Nueces and Ricardo Water Supply Corporations would have conducted lock-outs for non-payment of bills containing usage for January and February. However, staff consulted with legal counsel who advised not to perform any disconnections. This was later followed by action by the PUC issuing an order prohibiting disconnection of utilities in the State. The temporary suspension of disconnections does not apply to late fees – per my discussion with legal counsel. However, in these uncertain times, this too could change.

In addition, legal counsel has advised if a customer recently locked-out requests restoration of service, the Corporations should comply. Staff has interpreted this to mean the lock-outs done on March 16 prior to the standard, monthly disconnection date and as a result of NSF. Each Corporation has one account in that category. As of today, there has not been such a request.

#### Analysis:

Again, as the Board is aware, the pandemic has taken an economic toll. At this time, it is difficult to predict when "business will return to normal." Regardless, staff anticipates and legal counsel advises that special considerations will be needed for customers that do not pay their bills during this time once the threat is over and, hopefully, businesses, work and therefore wages return. For many years, the Corporations have operated under a set of disconnection, meter removal and cancellation procedures which allow specific amounts of time after the customer's second monthly bill goes unpaid.

At this point, the best information available in terms of revenue trends is to examine the collection rate for the month prior to the outbreak to the most recent month. Enclosed are reports from the billing program for the period of February 10<sup>th</sup> through March 9<sup>th</sup> (80.62%) and March 10<sup>th</sup> through April 9<sup>th</sup> (74.98%).

#### **Staff** Recommendation:

Legal counsel has advised that a six-month period may be required after social distancing restrictions are lifted for customers to get their personal finances back on track. Staff does not disagree with this assessment. However, as mentioned above, deciding to waive disconnection procedures for a six-month period will be a significant difference from typical operations. Estimating the financial impact this would have on the Corporations will be difficult to ascertain. Nonetheless, staff recommends the Board consider this as a very definite possibility.

### **Board Action:**

Provide feedback. Determine whether to develop a non-payment plan associated with COVID-19.

#### Summarization:

It should be noted that I have "attended" two (2) AWWA webinars on COVID-19 impacts to utilities. It is clear that the Federal government expects utilities to comply with all regulations. In fact, utilities are under a "heightened responsibility" to continue providing service. As one presenter stated, if a utility fails to comply with requirements it is not a good excuse to say COVID-19 has made it harder to conduct operations.

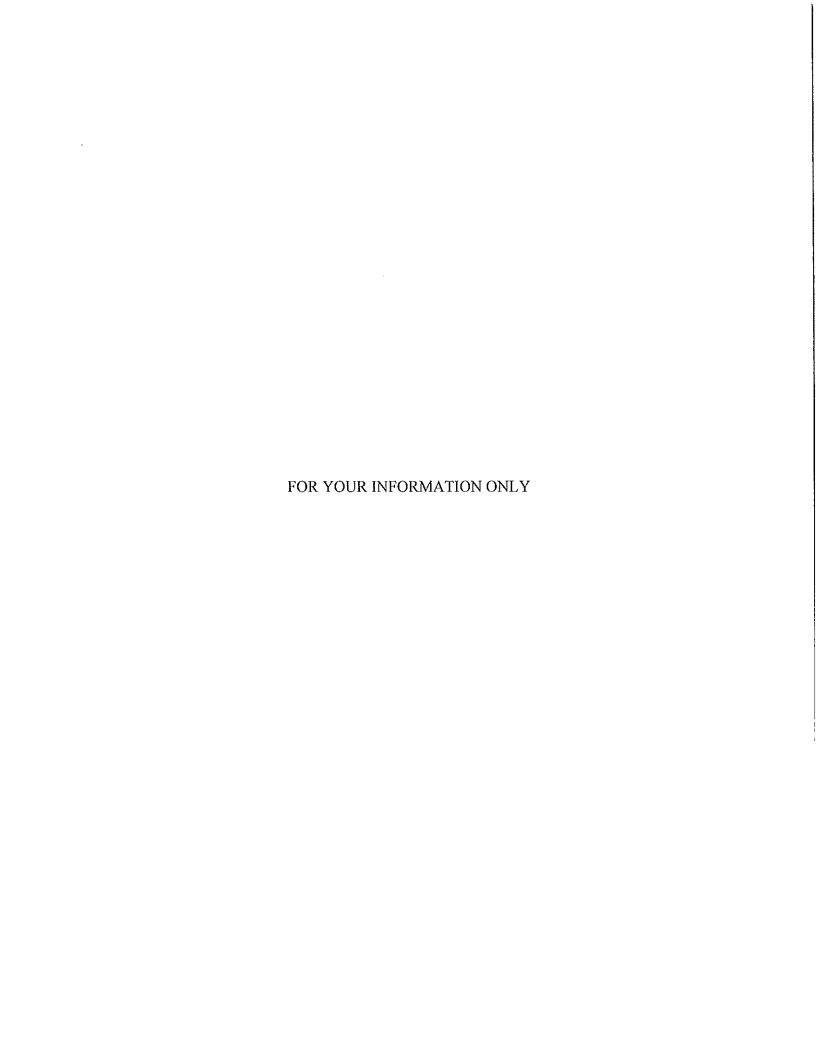

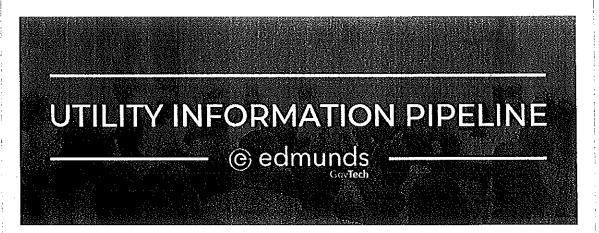

How are other utilities responding to the COVID-19 pandemic?

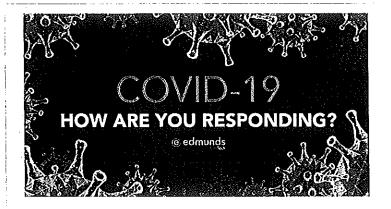

Dear Carola,

The thing on most everyone's mind these days is the COVID-19 virus. My hope is that each person reading this is safe and taking all the proper precautions to stay healthy and not spread the virus.

Trying to keep a utility business office functioning in a time of limited face-to-face contact is difficult, at best. I woke up a week ago yesterday (back when gatherings of 50 or less were still acceptable and restaurants were still seating guests!) wondering what preparations utilities were making.



To find out, I emailed about two dozen Utility Information Pipeline subscribers and asked if they were making any special accommodations, either for employees to work from home or taking any steps to assist customers during the pandemic.

## Limiting customer contact

As early as last Monday morning, March 16, the first utility to reply to my inquiry had already closed their lobby to customers. I've since heard from others who are taking steps to close to the public. If you have a drive-thru window, funneling all in-person transactions through the drive-thru is an excellent ideal.

Virtually everyone I heard from has plenty of antibacterial wipes and hand sanitizer on hand and are encouraging their staff to use it often. Many are also wearing gloves when opening mail and handling money. One customer who purchased <u>online service</u>

<u>applications</u>, but had yet to start using it live,
contacted me to see what steps they needed to take
to activate it. They were proactively looking for ways
to eliminate face-to-face contact for new customers
applying for service.

This is a great time to re-emphasize <u>alternatives to</u> <u>walk-in payments</u>. Remind your customers that <u>bank drafts</u> are available and encourage them to pay online. Many utilities are temporarily absorbing convenience fees in order to encourage more customers to pay online. Of course, this begs the question of <u>why charge a convenience fee</u> in the first place, but that's a conversation for another day!

## Working from home

In a customer-centric environment such as a utility business office, working remotely isn't generally a viable alternative. However, some employees, such as billing clerks and customer service representatives who primarily handle phone calls, are better suited to working remotely than are cashiers or face-to-face customer service staff.

Working remotely requires having the necessary technology infrastructure in place. This includes a Voice over IP (VoIP) phone system that can be answered anywhere and billing software that can be accessed from outside your office. Doing so requires a Virtual Private Network (VPN), if your billing system is hosted on-premise, or <u>cloud-based billing software</u>.

Not surprisingly, our sales team saw a significant uptick last week in the number of on-premise customers inquiring about moving to the cloud.

Keeping in mind that social distancing is appropriate even inside your office, some larger offices are platooning employees, alternating days or weeks of who works from home and who comes to the office.

## **Assisting customers**

As we've all heard repeatedly over the last few weeks, the best way to combat any virus is to wash your hands frequently using soap and hot water.

This, of course, requires running hot water. For that reason, many utilities have curtailed disconnecting for non-payment so as not to leave customers without water or a way to heat it.

Many utilities are also temporarily suspending late fees as well as disconnects. One wise utility did say that while they won't be charging a late fee or disconnecting for non-payment, they aren't making this public so customers who can pay will continue to do so.

#### Messaging to the public

I was flabbergasted last week at all the empty shelves of bottled water in grocery and convenience stores. Unlike a hurricane or other natural disaster that might render your water system temporarily out of service, water utilities everywhere will continue to treat and pump potable water during this pandemic. Everything I have read indicates the virus is not spread in water supplies, so tell your customers that!

Likewise, for "flushable" wipes if you operate a sewer system. As the general public stocks up on anti-bacterial wipes, some of which advertise themselves as flushable, remind your customers that they do not decompose and are not flushable!

Finally, if you are deferring late fees or cut-off fees, remind your customers that their utility bills are still due and, once things return to normal, you will again return to disconnecting for non-payment.

#### School of Government seminar

Yesterday, the UNC School of Government

presented an informative, interactive Zoom meeting for utilities operating during COVID-19. Hosted by Kara Millonzi (you do have her book on your desk, don't you?) and Shadi Eskaf, the session was targeted toward local government water and wastewater utilities. All of Kara's legal advice applied specifically to North Carolina, but there was still valuable information presented that would apply to any utility. In case you missed it, a recording of the meeting will be available at the <a href="School of Government website">School of Government website</a>.
