A motion was made by Mr. Zavala and seconded by Mr. Escobedo to approve the Treasurer's Report and payment of the bills. The motion carried.

- 5. All matters pertaining to TxDOT Upgrades on US 77/I69 at CR 2120/FM 772 and from CR 2130 south to CR 2230.
  - Funding Options

Ms. Serrato reported that return of the Corporation's 10% withheld amount (\$28,108.50) is expected very soon. She also mentioned that she spoke with Mireya Loewe of TWDB regarding the application and one of the items discussed was the possibility of a waiver for the environmental study. Ms. Loewe also told her about the TWDB's rural assistance fund which although it runs at a higher interest rate, allows for a 40-year term. The Board consensus was to pursue a 30-year loan. Ms. Serrato also reported that she and Eric Villarreal of Ardurra discussed funding of additional improvement projects if bids on the TxDOT adjustments are lower than the engineer's estimate. Mr. Villarreal reported to her that the designs are complete and should be submitted to TxDOT shortly. Ms. Serrato stated that staff will continue working on the application.

6. <u>Proposed Tariff Amendment – Section E (13) – Due Dates, Delinquent Bills, and Service</u> Disconnection Date.

Ms. Serrato presented the proposed amendment to Section E (13) of the RWSC Tariff modifying the disconnection of service cycle as discussed at the previous meeting. The change will allow

additional time to pay account balances before facing disconnection. Mr. Zavala made a motion to approve the recommended Tariff Amendment. Mr. Garza seconded and all voted in favor.

### 7. February 2021 Winter Storm/Freeze Event.

Ms. Serrato reported that the 10" valve at Pump Station #1 still needs to be replaced. In addition, the yard piping has been fixed at Pump Station #3, but the tanks need to be disinfected and bacteriological samples are needed prior to the pump station being placed back online. She stated that RWSC's total cost of damages is \$4,539.95. Insurance claims on the storm damage have been submitted. She stated that she would continue to provide updates to the Board.

### 8. Adjournment.

With no further business to conduct, Mr. Zavala made a motion to adjourn the meeting at 6:32 p.m. Mr. Hinojosa seconded and all voted in favor.

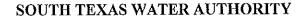

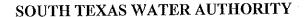

## Background:

Enclosed is bid information on the waterline adjustments necessary as a result of TxDOT upgrades to I-69 standards. The bid opening was held at 2:00 pm today. There were two (2) bids received. It appears, on a preliminary basis, that Abel's Paving and Construction Company, Corpus Christi, Texas is the lowest responsible bidder in an amount of \$357,482. The other bid was from Max Underground Construction, LLC, Corpus Christi, Texas in the amount of \$422,530. The engineer's estimate on the project was \$505,000. Hector Castaneda, Ardurra, indicated that a recommendation should be available by Tuesday's board meeting.

## Analysis:

Depending on the engineer's previous experience with the lowest responsible bidder, a recommendation to award should be available by the meeting on Tuesday. Regardless, this information will allow the Board to consider another agenda item, namely the amount of funds to be requested as part of a loan application to the Texas Water Development Board.

## Staff Recommendation:

If an engineer's review is complete, award the contract to the company recommended by the engineer.

#### Board Action:

Determine whether a company can be awarded the bid. If not, allow the additional time for the engineer to make a recommendation and meet again to formalize the award.

## **Summarization:**

## Background:

Previously, the Board authorized staff to work with Anne Burger-Entrekin, Hilltop Securities, and Noel Valdez, McCall, Parkhurst and Horton, on the submission of a loan to the Texas Water Development Board (TWDB). As stated previously, the engineer's \$505,000 estimate to construct the necessary adjustments to the Corporation's facilities should not be used to determine the loan request amount. With the opening of the bids today, a beginning amount is established should the Board decide to "replenish" funds which have been paid on the TxDOT project. In addition, there were several potential projects which the Board reviewed: (1) should the bids be lower than the \$505,000 estimate or (2) in terms of requesting more than the \$505,000 as a means of upgrading Corporation facilities.

## Analysis:

Enclosed is the cost information previously provided of three (3) possible projects, Pump Station #1 elevated storage tank rehab, construction of a 100,000-gallon ground storage tank at Pump Station #2 and replacing the majority of Pump Station #3 facilities. Those estimates together with the bid amounts will determine what amount to request from the TWDB. Once determined, staff will contact Ms. Burger-Entrekin for the financial breakdown and Mr. Valdez for the formal resolution. The last piece to this effort is the impact to the customers' rates. During the last meeting the Board determined that a 30-year loan would correlate to the term still remaining on the USDA debt. The Board should consider a "rule of thumb" figure that would be *acceptable* as part of a monthly minimum to repay the TWDB loan.

## **Staff Recommendation:**

## Determine:

- If a loan for only the cost of TxDOT adjustments is needed,
- Or, if additional funds should be requested,
- If additional funds are desired, select a specific project to include in the TWDB application,

## Board Action:

Decide on specifics for the TWDB loan application.

## Summarization:

Ricardo Water Supply Corporation's current monthly minimum is \$41.00. The Board needs to ask what is a reasonable increase to cover the cost of the adjustments and any other desired improvements.

## Ricardo Water Supply Corporation History and Financial Needs

The Ricardo Water Supply Corporation (RWSC) was created in the mid-1960's in and around the Ricardo School and Ricardo Feed Store/Co-op. For several decades, the Corporation was administratively run on a volunteer basis with paid staff added later on a part-time basis or contract basis depending on the services – billing, accounting, new services, fixing leaks, pump station operations and TCEQ required tasks.

The RWSC has three (3) pump stations in its distribution system. Pump Station #1 (PS#1) was the first station to be built in the 1960's and is located on the west side of US Highway 77 on CR 2160 across the street from the Ricardo School. Pump Station #2 (PS#2) was constructed in the 70's and is located on the east side of US Highway 77 on CR 2170. Pump Station #3 (PS#3) was also constructed in the 70's; it is the smallest of the stations and is located on the west side of US Highway 77 on CR 2140, also called Monitoring Road and named for the FCC Station that used to be located in the same vicinity. All three (3) pump stations had groundwater wells in the past. None of the groundwater wells remain in operation and have been plugged according to TCEQ requirements.

In 1983, an election was held asking the voters within the boundaries of the Ricardo Independent School District whether to be annexed into the South Texas Water Authority's (STWA) boundaries. The election passed. STWA was in the process of beginning construction on its Regional Water System which would transport treated surface water purchased from the City of Corpus Christi to communities in Nueces County and the City of Kingsville. In 1981, voters approved the issuance of \$17.0M in bonds for the Regional Water System. STWA utilized remaining bonds to extend service from the south side of Kingsville to RWSC's three (3) pump stations.

At that time, the RWSC's customer base was approximately 300 connections. STWA worked with the RWSC and procured funds on the Corporation's behalf from the Texas Water Development Board (TWDB) to expand RWSC's distribution system, which occurred in three (3) phases. With the construction of the 3<sup>rd</sup> phase, RWSC's customer count was close to 650 connections. The RWSC was able to accelerate payment on this TWDB debt as shown in the attached timeline.

In 1991, the RWSC Board entered into a turn-key contract with STWA for management and operation services. Today's customer count is approximately 1,065 connections. In addition to new distribution water lines, several other improvements were made through the years. An elevated storage tank was constructed with Kleberg County's assistance through a grant project in 2002. In the last decade, additional improvements were made with the construction of a 12" transmission waterline which directly connects its three (3) pump stations to STWA's surface water supply on the north side of the City of Kingsville and the construction of an elevated storage tank at PS#2. New pump station buildings have been constructed at PS#1 and PS#2.

However, the Corporation has experienced a recent setback as a result of TxDOT upgrades of US Highway 77 to I-69 standards. The first TxDOT project at CR 2120 was reimbursed at 100% and the Corporation had been advised its lines south of that crossing would likely not be affected. This was not the case as a result of drainage structures and additional right-of-way requiring extending casing on four (4) previously permitted TxDOT crossings as well as combining a 6" and a 3"

waterline into one (1) line and relocating the new line in another public right of way corridor. The estimated cost for these four (4) adjustments is \$500,000+. (See attached engineer's estimate.)

With this unexpected financial burden, the Corporation is faced with delaying projects:

- PS #1 Elevated Storage Tank Complete Repainting at a cost of \$250,000+. This tank has been periodically worked on through the years:
  - o In 2006 at a cost of \$20,700
  - o In 2013 at a cost of \$36,900
  - o In 2017 at a cost of \$25,000
- PS#2 Ground Storage Tanks this pump station originally had four (4) tanks each with a capacity of 21,000 gallons. In 2020, one of the tank's roof failed. With the recent Winter Storm Uri, additional problems have surfaced on another tank. The Corporation is proposing to replace the three (3) remaining tanks with a 100,000 gallons steel bolted tank at an estimated cost of \$200,000.
- PS#3 Complete Refurbishing as mentioned above, this is the smallest station, in terms of capacity, in RWSC's distribution system. There are currently two (2) pumps with 40 gpm capacity. There are two (2) concrete tanks each with a capacity of 21,000 gallons. There is not an elevated tank located at this station; instead, there is a 7,000-gallon hydro-pneumatic tank providing a pressure plane. In addition, there is not an emergency generator located at this station. The building is the original wooden structure which is in need of replacement. The estimated costs are as such:
  - o New pumps (2) \$60,000
  - o New 100,00 gallon capacity GST including base, piping disinfection \$190,000
  - o New Hydro-pneumatic Tank (1) \$80,000
  - o New Emergency Generator with ATS \$100,000
  - New Pump Station Building with electrical wiring- \$40,000
  - o New SCADA and Controls \$10,000

Eric,

I left a voice mail message for you this morning about a meeting RWSC board members and I had with the Kleberg County Judge, Rudy Madrid, Commissioner David Rosse and grant writers with Santos McBain Management and Planning.

RWSC Board President Baldemar Garcia spoke about the county assisting RWSC with the cost of the TxDOT adjustments as well as needed improvements at Pump Stations 1, 2 and 3.

Pump Station 1 on CR 2160 needs the elevated storage tank to be repainted. Attached is a memo from about a year ago with information on quotes to paint that EST.

Pump Station 2 on CR 2170 needs a new ground storage tank to replace the existing concrete tanks. With the recent Winter Storm Uri, additional problems have surfaced with the tanks. Last year, one tank collapsed. There are three remaining tanks with a capacity of 21,000 gallons – 63,000 gallons total. The elevated storage tank at that location is 150,000. We believe a single tank should be constructed as a replacement.

And, Pump Station 3 needs to be upgraded in its entirety: pumps, ground storage tanks and building. This is the smallest of the pump stations and is actually offline since PS 1 and 2 can accommodate all of the customers. It should be noted that there is not a generator at this station. The construction of this station will require a full review by TCEQ.

At this time, the county's consultant is asking for a cost estimate on these four (4) items: TxDOT, PS 1 EST, PS 2 GST and PS 3.

We have your breakdown on TxDOT and last year's quotes on PS 1 paint work. However, would Ardurra be able to assist with some type of estimates on the other items? Also, I am wondering if the paint quotes could be updated.

## Background:

With regards to the quotes for the paint work on the EST at PS #1, Diamond Enterprises (Diamond) continues to express an interest in the project. Staff repeatedly contacted NG Painting after the December Board meeting, to no avail. Staff also contacted a company used by Mercer Controls, Inc. by the name of Fastco Sandblasting and Painting. Mr. Oscar Juarez responded by stating that his company does not work on elevated storage tanks. Another company that recently did work for the Nueces Water Control and Improvement District #3 in Robstown by the name of Texas Tank Service (TTS) was contacted. Enclosed is their quote. And finally, staff thought Pittsburg Paint and Tank Group was going to submit a quote; however, enclosed is the email correspondence indicating that their company already had two (2) containment projects and did not have the resources to add a third job.

## Analysis:

The two (2) quotes submitted by Diamond and TTS are enclosed. Warranty work is typically one-year. However, TTS is indicating on the less costly option that there is no warranty.

## Staff Recommendation:

Mr. Archie Wilkins with Diamond is indicating that the more expensive option should last 12 to 15 years and the second option should last 8 to 10 years. Staff has not worked with TTS; however, according to Armando Yruegas, O&M Supervisor, NCWCID#3 was very satisfied with their work. However, with regard to the lowest option, staff is wary of the lack of any warranty on the work.

## Board Action:

Provide feedback to staff. Determine if additional research or quotes are needed.

## Summarization:

Tank work is needed. The difficult part is making a decision about how extensive the job should be while weighing the cost and the Corporation's available resources keeping in mind the TxDOT project, which although it is reimbursable can take considerable time before the Corporation's money is received.

## Background:

Several years ago, letters were sent to customers informing them of the need to install cut-off valves outside of the Corporation's meter box. In addition, as part of a new customer's application process, the new member is informed of the need for their own cut-off valve. However, meters continue to be reported by field personnel of curb stops being used to shut-off water downstream of the meter. In addition, customer's will call asking for field personnel to shut-off their water using the curb stop. At this time, staff is aware of two (2) customers that are in violation of the Corporation's policy to have a cut-off valve.

## Analysis:

Although the lack of a cut-off valve was made more evident during the February freeze event, this matter has been an issue for quite some time. Most customers will comply with the notice to install a cut-off valve. However, there are other instances when the notice is ignored. As such legal counsel was sought and the attached letter drafted for his review. He has indicated that the letter is appropriate.

## Staff Recommendation:

Authorize use of the attached letter for members that are in violation of the Corporation's policy to install a cut-off valve.

## **Board Action:**

Determine whether to authorize use of the attached letter for members that are in violation of the Corporation's policy to install a cut-off valve.

## Summarization:

The availability of a cut-off valve is a benefit to customers and the Corporation alike in the event of a leak on the customer's side.

This letter is Final Notice of a Violation of Corporation Policy. Enclosed is previous correspondence dated April 29, 2021 notifying you of the need to install a cut-off valve. According to our files and field inspection, this valve, which should be located immediately downstream of the Corporation's meter, has not been installed. This valve, required to be furnished by the property owner or member, is addressed in the Corporation's Tariff in several sections. Enclosed are pages E-6 & E7, E-11 and G-2 & G-3 of the Tariff.

Rules for Disconnection of Service, beginning at the bottom of page E-6 and continuing on page E-7, states in Section 14.A.(iv) that service can be disconnected for "Failure of the Member to comply with the terms of the Corporation's Service Agreement, Tariff, Bylaws, or Special Contract provided that the Corporation has given notice of said failure to comply and Member has failed to comply within a specified amount of time after notification."

In addition, on page E-11, Section 23.E. states "The Corporation shall require each Member to provide a cut-off valve on the Member's side of the meter for purposes of isolating the Members' service pipeline and plumbing facilities from the Corporation's water pressure. The Member's use of the Corporation's curb stop or other similar valve for such purposes is prohibited. Any damage to the Corporation's equipment shall be subject to service charges."

Finally, beginning on page G-2 and concluding on page G-3, Section 12, <u>Equipment Damage Fee</u>, further clarifies the Corporation's position regarding the cost of any damage or fees to be assessed as a result of the unauthorized use of the Corporation's facilities.

As such, you must install the required cut-off valve by July 30, 2021. Failure to install said valve will result in disconnection of service. Restoration of service will require payment of re-connection fees per the enclosed fee schedule.

- F. Failure to pay the bill of another customer at the same address except where the change of customer identity is made to avoid or evade payment of a utility bill;
- G. Failure to pay for the restoration of a tap removed by the utility at its option or removed as the result of tampering or delinquency in payment by a previous customer;
- H. Failure to comply with regulations or rules for anything other than the type of utility service specifically requested including failure to comply with septic tank regulations.
- 11. <u>Deferred Payment Agreement</u>. The Corporation may offer a deferred payment plan to a Member who cannot pay an outstanding balance in full and is willing to pay the balance in reasonable installments as determined by the Corporation, including any Late Penalty Fees or interest on the monthly balance to be determined as per agreement.

## 12. Charge Distribution and Payment Application.

- A. The Minimum Monthly Charge or the Reserved Service Charge is applied from the twelfth day of the month to the twelfth day of the next month. Charges shall be prorated for meter installations and service terminations falling during the calendar month. Billings for this amount shall be mailed on or about the 13<sup>th</sup> of the month preceding the month for which this charge is due. All services shall be subject to this charge whether or not the service is in use by the Member.
- B. Gallonage Charge, defined as water usage in excess of the water allotment included in the Minimum Monthly Charge, shall be billed at the rate specified in Section G, and shall be billed in one thousand (1000) gallon increments. Water charges for usage exceeding the monthly allotment are based on monthly meter readings and are calculated from reading date to reading date. Readings used in all billing calculations shall be taken by the Corporation's employees or designated representative.
- C. Posting of Payments -- All payments shall be posted against previous balances prior to posting against current billings.
- 13. Due Dates, Delinquent Bills, and Service Disconnection Date. The Corporation shall mail all bills on or about the 15th of the month. All bills shall be due by the date indicated on the bill (allowing approximately twenty five (25) days to pay), after which time a penalty shall be applied as described in Section G. A bill is delinquent if not paid by the due date. Payments made by mail will be considered late if not received in the Corporation's mail receptacle on or before due date. Payments made by drop box will be considered late if not received in the Corporation's office before the due date or by 4:59 pm on the due date. Payments made using the computer online service will be considered late if not made by the customer by 4:59 pm on the due date. Lockout notices will be sent immediately or as soon thereafter as possible following the due date for the second month in arrears. Lockout notices shall be mailed allowing seven (7) additional days for payment prior to disconnection. The seven (7) additional days shall begin on the day the lockout notice is deposited with the U.S. Postal Service with sufficient postage. If the due date for the regular billing is on a weekend or holiday, the due date for payment purposes shall be the next day the Corporation office is open for business after said weekend or holiday. Payment must be received whether made in person, drop box, U.S. Postal Service or using the online computer service by 4:59 pm on the business day before the actual disconnection date in order to avoid incurring a service charge/cutoff fee.
- 14. Rules for Disconnection of Service. The following describes the rules and conditions for

## disconnection of service:

- A. Disconnection With Notice -- Water utility service may be disconnected for any of the following reasons after proper notification has been given:
  - (i) Returned Checks -- In the event a check, draft, or any other similar instrument is given by a person, firm, corporation, or partnership to the Corporation for payment of services provided for in this Tariff, and the instrument is returned by the bank or other similar institution as insufficient or non-negotiable for any reason, the Corporation shall mail, via the U.S. Postal Service, a notice requiring redemption of the returned instrument within ten (10) days of the date of the notice to be made in the Corporation office. Redemption of the returned instrument shall be made by cash, money order, or certified check. Failure to meet these terms shall initiate disconnection of service
  - (ii) Failure to pay a delinquent account for utility service or failure to comply with the terms of a deferred payment agreement;
  - (iii) Violation of the Corporation's rules pertaining to the use of service in a manner which interferes with the service of others or the operation of non-standard equipment if a reasonable attempt has been made to notify the Member and the Member is provided with a reasonable opportunity to remedy the situation;
  - (iv) Failure of the Member to comply with the terms of the Corporation's Service Agreement, Tariff, Bylaws, or Special Contract provided that the Corporation has given notice of said failure to comply, and Member has failed to comply within a specified amount of time after notification.
  - (v) Failure to provide access to the meter under the terms of this Tariff or to property at which water service is received when there is reason to believe that a hazardous condition or policy violation exists for which access is necessary to verify.
  - (vi) Misrepresentation by any Applicant or Transferee of any fact on any form, document, or other agreement required to be executed by the Corporation.
  - (vii) Failure of Member to re-apply for service upon notification by the Corporation that Member no longer meets the terms of the service classification originally applied for under the original service application.
- B. Disconnection Without Notice -- Water utility service may be disconnected without notice for any of the following conditions:
  - (i) A known dangerous or hazardous condition exists for which service may remain disconnected for as long as the condition exists, including but not limited to a violation of the Texas Sanitation and Health Protection Law 4477-1, or there is reason to believe a dangerous or hazardous condition exists and the Member refuses to allow access for the purpose of confirming the existence of such condition and/or removing the dangerous or hazardous condition;
  - (ii) Service is connected without authority by a person who has not made application for service or who has reconnected service without authority following termination of services for nonpayment; and
  - (iii) In instances of tampering with the Corporation's meter or equipment, by-passing the meter or equipment, or other diversion of service. Where reasonable, given the nature of the reason for disconnection, a written statement providing notice of disconnection and the reason therefor shall be posted at the place of common entry or upon the front door of each affected residential unit as soon as possible after service has been disconnected.

Texas Department of Health Rules and Regulations.

- (i) All connections shall be designed to ensure against back-flow or siphonage into the Corporation's water supply. In particular, livestock water troughs shall be plumbed above the top of the trough with air space between the discharge and the water level in the trough.
- (ii) The use of pipe and pipe fittings that contain more than 8.0% lead or solder and flux that contain more than 0.2% lead is prohibited for any plumbing installation or repair of any residential or non-residential facility providing water for human consumption and connected to the Corporation's facilities.

Service shall be discontinued without further notice when installations of new facilities or repair of existing facilities are found to be in violation of this regulation until such time as the violation is corrected. All service connections provided after January 1, 1996 will include, at the member's cost, the installation of necessary backflow prevention devices. All service connections provided after January 1, 1996 will be inspected by a licensed inspector for the presence of cross-connections. Provision of service will be contingent upon the results of said inspection.

- C. A Member owning more than one (1) Membership Certificate shall keep all payments current on all accounts. Failure to maintain current status on all accounts shall be enforceable as per Service Application and Agreement executed by the Member.
- D. The Corporation's ownership and maintenance responsibility of water supply and metering equipment shall end at the point where the Member connects to the equipment provided by the Corporation during the installation of the metering equipment. Therefore, all water usage registering upon and/or damages occurring to the metering equipment owned and provided by the Corporation shall be subject to charges as determined by the Corporation's Tariff as amended from time to time by the Board of Directors.
- E. The Corporation shall require each Member to provide a cut-off valve on the Member's side of the meter for purposes of isolating the Member's service pipeline and plumbing facilities from the Corporation's water pressure. The Member's use of the Corporation's curb stop or other similar valve for such purposes is prohibited. Any damage to the Corporation's equipment shall be subject to service charges.

be required to contribute capital in an amount projected to defray the cost of up-grading system facilities to meet growth demands created by adding customers. This fee shall be assessed immediately prior to providing or reserving service on a per residential meter equivalent basis for each tap/lot and shall be assigned and restricted to the tap/lot for which the service was originally requested.

## 6. Monthly Charges.

- A. Minimum Monthly Charges -- The monthly charge for metered water service, including allowable gallonage, is as defined on the fee sheet.
- B. Reserved Service Charges -- The monthly charge for each active account at a specific location for which a meter has not been installed but for which the Corporation and the Applicant have entered into agreement and/or contract for reserved service. This monthly charge shall be based on the Corporation's monthly operating costs to service the Applicant's dedicated facilities on a per lot/tap or meter equivalency basis. This charge reserves service to the Applicant's service area. This fee is determined on a case by case basis but shall never exceed the Minimum Monthly Charge for Metered Service on a per lot/tap basis for each designated meter size.
- 7. <u>Late Payment Fee.</u> A penalty of per billing period shall be made on delinquent bills. This late payment penalty shall be applied to any unpaid balance during any one billing period.
- 8. <u>Ownership Notification Fee.</u> The Corporation may, at the expense of the Member, notify said Member of a renter/lessee delinquent account status prior to disconnection of service.
- 9. Returned Check Fee. In the event a check, draft, or any other similar instrument is given by a person, firm, corporation, or partnership to the Corporation for payment of services provided for in this Tariff, and the instrument is returned by the bank or other similar institution as insufficient or non-negotiable for any reason, the account for which the instrument was issued shall be assessed a return check charge.
- 10. <u>Re-Service Fee.</u> The Corporation shall charge a fee for reconnecting service after the Corporation has previously disconnected the service for any reason provided for in this Tariff.
- 11. <u>Service Trip Fee.</u> The Corporation shall charge a trip fee for any service call or trip to the Member's tap as a result of a request by the Member or resident (unless the service call is in response to damage of the Corporation's or another Member's facilities) or for the purpose of disconnecting or reconnecting service due to non-payment for services.
- 12. Equipment Damage Fee. If the Corporation's facilities or equipment have been damaged by tampering, by-passing, installing unauthorized taps, reconnecting service without authority, or other service diversion, a fee shall be charged equal to the actual costs for all labor, material, and equipment necessary for repair, replacement, and other Corporation actions. This fee shall be charged and paid before service is re-established. If the Corporation's equipment has not been damaged, a fee equal to the actual costs for all labor, material, equipment, and other actions necessary to correct service diversions, unauthorized taps, or reconnection of service without authority shall be charged. All components of this fee will be itemized, and a statement shall be provided to the Member. If the Corporation's facilities or equipment have been damaged due to negligence or unauthorized use of the Corporation's

equipment, right-of-way, or meter shut-off valve, or due to other acts for which the Corporation incurs losses or damages, the Member shall be liable for all labor and material charges incurred as a result of said acts or negligence.

- 13. <u>Customer History Report Fee.</u> A fee shall be charged to provide a copy of the Member record of past water purchases in response to a Member's request for such a record.
- 14. <u>Meter Test Fee.</u> The Corporation shall test a Member's meter upon written request of the Member. Under the terms of Section E of this Tariff, a charge shall be imposed on the affected account.
- 15. <u>Transfer Fee.</u> An Applicant for service who is a Transferee shall complete all required application forms, etc., and pay a Transfer Fee.
- 16. <u>Membership Certificate Copy Fee.</u> A fee will be charged to provide a duplicate copy of the Membership Certificate.

#### Background:

Enclosed is information from Mr. Cesar Silva, developer of the La Conquista Ranch Subdivision. The proposed subdivision is a 26-lot development that cannot be served by simply extending the existing line which is located south of the property. Rather, a parallel 3" waterline will be needed that will tap into an existing line on CR 2150 and extend north and west for 10,616 LF.

#### Analysis:

A 2" line, according to TCEQ should supply no more than ten (10) residential service connections. A 2 ½" waterline should supply no more than twenty-five (25) connections. The line closest to the proposed subdivision is a 2" line which was paid for by Mr. Paul Baca for his Wildlife Acres subdivision.

An analysis of the amount of capacity that this subdivision will impact the existing pump station and waterlines has been completed. See enclosed analysis. However, the cost of the 3" waterline has not been completed for several reasons:

- The field crew is still short by one technician.
- Even with an additional technician, allocating time for a two-mile extension would take an extended period of time.
- Aaron Archer, Walker Partners, has questioned whether the Board would want to consider oversizing of the line.
- Two bores, which would be outsourced, will be necessary. I have double-checked with Commissioner David Rosse, who has stated that no open-cut of CR 2150 and/or CR 2140 will be allowed. This means quotes will be needed for those bores – including the size of the line whether oversized or not.
- I personally spoke with Mr. Silva and explained the man-power issue and offered to discuss the possibility of an arrangement similar to that made for the King Junior Estates Subdivision, which required approval of the extension plans, materials and inspection of the work.
- Finally, Mr. Silva has now approached office staff about a development in a different area instead of this location.

#### **Staff Recommendation:**

Staff believes it is in the best interest of the developer and Corporation to discuss the developer hiring a contractor installing the waterline as done with the King Junior Estates Subdivision. Legal counsel Bill Flickinger should be consulted to draft a contract similar to the contract used in that transaction. Mr. Silva would still be responsible for his pro-rated share of the capacity of existing facilities. Once the line is installed (with a 1-year warranty), title to the line would be transferred to the RWSC – the same as with King Junior Estates.

## **Board Action:**

Determine whether to agree, in principle, to allowing Mr. Silva to hire a contractor to install the necessary extension. As stated in the "Recommendation," the matter would be formalized by contracts.

## **Summarization:**

It does not escape staff that the addition of 26 new customers is good news for the Corporation. However, it also needs to be repeated that field personnel remain very busy with the routine, State required items that are part of keeping a utility in compliance.

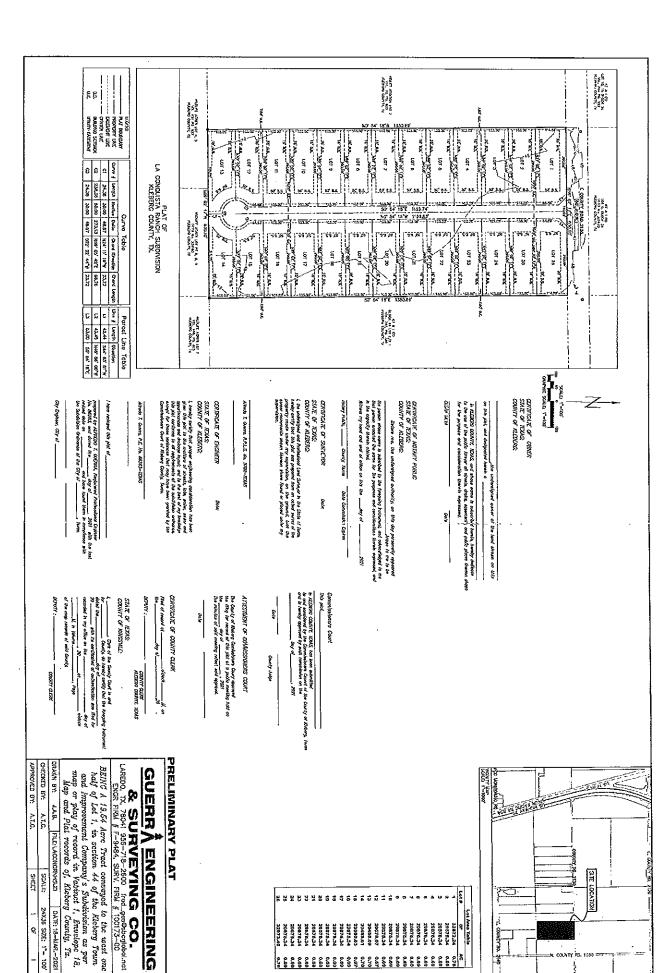

E., Walker Partners. The enclosed Developer Contract must be signed and returned with your payment. As we discussed the cost analysis is to furnish service to twenty-six (26) lots in the subdivision. I have taken the liberty of highlighting the cost analysis figures on your copy. Those figures are as follows:

## Additional improvement required: Water line extension

Mr. Aaron Archer, P. E., Walker Partners has recommended that a 3' waterline be installed.

The installation of approximately 10,616LF of 3" water line, two (2) road bores (CR 2140 and CR 2150) and possibly two (2) driveway bores will require utilizing a contractor. The measurements do not reflect a looped line into the subdivision; lots located on the opposite side of the installed water line will require a long service road bore for their connections.

In addition to a set of plans and material specifications, the hired contractor must provide Ricardo Water Supply Corporation a Certificate of Insurance and a Workers Compensation Policy with a minimum of one million dollars coverage. As we discussed, this is an item to be presented to the RWSC Board.

\*\* This cost estimate is only good for thirty days from the date on this letter.

Before payment is accepted for this development the plat must be approved by the Kleberg County Commissioners Court and filed at the Kleberg County Clerk's office for recording.

As indicated previously, these fees provide for twenty-six (26) service connections. It does not include the cost of individual service connections. The lot owner will pay a discounted cost of \$1,010.00, provided that a long service road bore is not required to complete the connection to the lot. The developer discount of \$300.00 is applied to the standard cost of \$1,310.00. There are no rebates or refunds once the lot is serviced.

I like to inform potential customers that once the service is extended to the property, the only portion of the fees which is refundable is the \$200.00 membership fee. This \$200.00 fee will be returned to the member in the event the membership is canceled, provided they do not owe any outstanding fees or bills to the Corporation.

Enclosed please find a copy of the Developer Contract which requires your signature. Please submit your approved and recorded plat. You may submit payment in the amount of \$12,487.24. However, the RWSC Board will be considering this mater on July 27, 2021 and they may determine that additional information is necessary regarding the installation of the extension, which is <u>not</u> part of this amount. # Ricardo Water Supply Corporation Cost Analysis to serve La Conquista Ranch Subdivision, containing twenty-six (26) lots, located on CR 2130

The purpose of this analysis is to determine the estimated cost for the Ricardo Water Supply Corporation (RWSC) to provide water service to 26 lots in the La Conquista Ranch Subdivision. The cost for providing service will include a pro-rata share of the existing improvements, any new improvements, and any engineering costs incurred.

The first step of the cost analysis will estimate the pro-rata share of RWSC's existing improvements that are impacted by your service request. The improvements impacted are Pump Station #1 and the water distribution system to your property. The projects that have costs associated with these improvements are RWSC Water System Improvements Phase 2 (1988), 2002 Overhead Tower Construction, 2004 Water System Improvement and the addition of a liquid ammonia sulfate disinfecting system, 2005, and building repairs, 2017.

Based on the information provided, the property will have 26, connections. The pro-rata share of the existing improvements will be based on the 26 connections for the Subdivision divided by the total capacity of the improvements times the cost of the improvement.

In reviewing the Texas Commission on Environmental Quality (TCEQ) "Rules and Regulations for Public Water Systems," the following capacity criteria will be used to determine the total capacity of the RWSC Improvements.

- Capacity criteria for hydropneumatic tanks are 20 gallons per connection.
- Capacity criteria for 150,000-gallon overhead tower is 100 gallons per connection.
- Capacity criteria for service pumps are 0.6 gallons per minute (gpm) per connection.
- Capacity criteria for 2-inch water lines are 10 connections.
- Capacity criteria for 2.5-inch water lines are 25 connections.
- Capacity criteria for 3-inch water lines are 50 connections.
- Capacity criteria for 4-inch water lines are 100 connections.
- Capacity criteria for 6-inch water lines are 250 connections.
- Capacity criteria for 8-inch water lines are 400 connections.
  Capacity criteria for 10-inch water lines are 650 connections.
- Capacity criteria for 12-inch water lines are 900 connections.

The following is the calculations of the pro-rata share of RWSC's existing distribution system that is impacted by the Subdivision.

#### A. Pump Station No. 1 (CR 2160)

- 1. Phase 2 Improvements at Pump Station No. 1 include the following:
  - a. 2-500 gallon per minute service pumps,
  - b. chlorination feed system, and miscellaneous piping
  - c. electrical, and control improvements.

The costs of the Improvements for Pump Station No. 1 were \$89,595.49.

The capacity of Pump Station No. 1 based on the service pumps is 1,667 connections (2 pumps x (500 gpm capacity each / 0.6 gpm per connection). For this analysis, the capacity of Pump Station No. 1 is based on the two service pumps that will be used to calculate your pro-rata share. The pro-rata capacity of the Phase 2 Improvements for the single lot is 1.6% (26 connections / 1,667 connections). The pro-rata cost of the Phase 2 Improvements for the subdivision is \$1,433.52 (0.016 x \$89,595.49).

2. 2002 Overhead Tower Construction (150,000-gallon capacity)

The costs of the Overhead Tower Construction were \$269,100.00. The capacity of the Overhead Tower is 1,500 connections (150,000 gallons / 100 gallons per connection). The pro-rata capacity of the Overhead Tower for the subdivision is 1.73% (26 connections / 1,500 connections). The pro-rata cost of the 2002 Improvements for the lot is \$4,655.43 (.0173 x \$269,100.00).

#### B. Distribution System

1. 2004 Water System Improvements

The costs of the Improvements include the total cost of the distribution lines, which also includes valves and road bores. The following is a list of the items and associated costs for the Improvements that is impacted by the connection of the subdivision:

a. 6-inch water line from pump station to CR 2160
6,336LF- 6" pipe, gate valves and road bores \$ 61,522.00

Total 6-inch water distribution system \$ 61,522.00

The capacity of the 6-inch water line is 250 connections. The pro-rata capacity of the 2004 Water System Improvements for the subdivision is 10.4 % (26 connections /250 connections). The pro-rata cost of the 2004 Water System Improvements – Distribution Lines is \$ 6,398.29 (0.104 x \$ 61,522.00).

# C. Engineering Cost

The Engineering costs for determining the costs of the pro-rata share of the existing system to serve twenty-six (26) connections in your subdivision is \$1,000.00. This cost is split as such, \$200.00 in-house capacity analysis and \$800.00 for the analysis review by Mr. Aaron Archer, P. E., Walker Partners.

The total of all prorata costs (excluding membership, tap fees, water line extension and service lines for individual customers) for the Ricardo Water Supply Corporation to provide water service to your 26-lot subdivision on CR 2130 is \$13,487.24 (\$1,433.52 + \$4,655.43 + \$6,398.29 + \$1,000.00).

## WATER SUPPLY AND DEVELOPMENT CONTRACT

#### WITNESSETH:

WHEREAS, RWSC has a contract with South Texas Water Authority, a governmental agency, conservation and reclamation district and body politic and corporate, to obtain water for supply to areas which lie outside of the jurisdictional limits of the other existing incorporated cities, water districts, or other municipal corporations which lie within the boundaries of South Texas Water Authority; and

WHEREAS, the South Texas Water Authority has an agreement dated October 14, 1980, with the City of Corpus Christi to obtain treated water from the City of Corpus Christi which gives the South Texas Water Authority the capacity to serve customers lying within the established boundaries of the South Texas Water Authority; and

WHEREAS, both RWSC and Developer recognize the terms of this contract are subject to all the terms and conditions of the contract between the City of Corpus Christi and South Texas Water Authority as well as the contract between South Texas Water Authority and RWSC, and incorporate the terms of each of said contracts by reference into the instant contract; and

WHEREAS, Developer desires to obtain a commitment from RWSC to supply water to a subdivision, as hereinafter described, which Developer has platted; and RWSC desires to supply water to such subdivision under the terms and conditions as hereinafter stated.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, RWSC agrees to supply water under the terms and conditions and for the considerations hereinafter set forth, to-wit:

- From and after the effective date of this agreement specified in paragraph 5 below,
   Developer shall have the right to have water supplied to Developer's subdivision by RWSC in Kleberg County, Texas at a point described and depicted in Exhibit A, attached hereto and incorporated herein by reference.
- 2. Water provided by RWSC shall be exclusively used within the service area described in Exhibit A, referred to above. Developer warrants and certifies that the described area within which said subdivision lies neither wholly nor partially within the jurisdictional area of an existing city, municipal corporation, water improvements district or water control and improvement district which have a prior right to supply water to the subdivision, but are situated completely within the boundaries of South Texas Water Authority and within the area served by RWSC.
- 3. RWSC makes no guaranty that water will be available at any particular time or place; it being fully understood by both parties hereto that the ability of RWSC to supply water is subject to its contract with South Texas Water Authority which is subject to South Texas Water

Authority's contract with the City of Corpus Christi for the supply of water, all terms of both agreements being herein incorporated by reference, and that this instrument is merely an agreement to allow withdrawal of water from the system operated by RWSC, when and if same is present and available.

- 4. As a precedent to RWSC having a duty to supply water to Developer's subdivision, Developer must:
  - (a) meet all flood plain, platting and subdivision requirements of the contract between the City of Corpus Christi and South Texas Water Authority and the contract between South Texas Water Authority and RWSC as well as local city, county, state or federal ordinances or laws and by the Federal Grant and Loan Agreements of which South Texas Water Authority and RWSC are subject as shall be specified by RWSC;
  - (b) make a deposit sufficient as determined solely by RWSC, to pay for the oversizing of the line(s) and/or increased pumping capacity necessary to service the subdivision as reasonably required when fully developed as platted; such deposit to be made prior to the servicing of said subdivision. Upon Developer having met all requirements, including payment for the increased capacity of the water system as stated hereinabove, RWSC shall have the duty to provide water to the subdivision to the extent of the increased capacity, as needed by the subdivision. If at the end of seven (7) years from the date water service first became available to the subdivision, such increased capacity is not being fully utilized for service of the subdivision, from such

time RWSC, South Texas Water Authority or the respective assigns of either, shall have the right to allocate the use of such excess capacity for other customers.

Developer, during such seven (7) year period shall not be entitled to the exclusive use of such increased capacity unless or until all of the increased capacity is actually required in order to serve the subdivision or development.

- (c) submit for RWSC review and approval, all plans and specifications for water improvements within the development prior to construction. The Developer shall conform with all material and construction specifications of South Texas Water Authority and RWSC for water system improvements within the development prior to construction.
- (d) notify RWSC prior to the beginning of construction of the water distribution system within the subdivision so that RWSC may inspect the work in progress.
- (e) upon completion of construction of the water distribution system within the subdivision, submit as-built drawings and dedicate the water system improvements and an easement twenty feet (20') in width (or ten feet [10'] if the easement is adjacent to a public road or street) conforming to the outlines of the water distribution system as reflected by the said plat and as-built drawings, to RWSC or its assigns after final inspection and approval by an authorized representative of RWSC.
- 5. This agreement shall not be considered effective or a binding obligation against RWSC until Developer has made all deposits and met all requirements called for by this Agreement.

- 6. Subject to Developer's duty to pay for the increased capacity of the line as stated hereinabove, RWSC will provide water service to the boundary line of the subdivision. Developer shall be financially responsible for the construction of the water distribution system within the subdivision.
- 7. RWSC will neither accept the dedication of the water system improvements nor provide water to the subdivision unless at the time of the dedication by Developer, Developer also submits to RWSC on forms supplied by RWSC, an affidavit executed by each contractor and subcontractor who has either supplied materials or labor to Developer for the construction, that contractor or subcontractor has been paid for the work performed, as well as an affidavit by Developer that Developer has paid for all work and materials supplied for the construction of the water system improvements.
- 8. Developer shall have no right to sell water to purchasers of lots within the subdivision and understands and agrees that each property owner within the subdivision will sign an individual water service contract with RWSC, or its assigns, before water service will be provided to the property owner desiring service.
- 9. Any expansion of the subdivision beyond the boundaries as shown by the plat attached hereto as Exhibit "B" will require that the Developer enter into a new water supply and development standards contract with RWSC, or its assigns, containing generally the same provisions as the instant contract.

- 10. RWSC reserves the right to designate the point at which Developer will have the right to tie into the RWSC water system.
- 11. In further consideration of RWSC's agreement to provide water to the boundary line of the subdivision, Developer warrants and covenants that:
  - a. Developer is the owner of record of the land described in the plat attached hereto as Exhibit "B".
  - b. The name of the subdivision is La Conquista Ranch Subdivision.
  - c. The entire land contained within the subdivision and for which Developer enters into this Water Supply and Development Contract is described on a subdivision plat attached hereto as Exhibit "B".
  - d. The land contained within the subdivision is held by Developer under deed recorded in the Deed Records of the Kleberg County Clerk's office as follows: Cabinet 1, Envelope 18.
  - e. All taxes which are liens on the land at the date hereof have been paid.
  - f. There (are) (are not) any encumbrances or liens against the land. (Specify encumbrances, if any.)

- 12. Developer will indemnify and save RWSC harmless from any and all claims or demands whatsoever to which RWSC may be subjected by reason of any injury to any person or damage to any property resulting from or in any way connected with any and all actions and activities (or failure to act) of Developer under this contract. Developer shall be solely responsible for obtaining any permits or easements for the use of land owned by others, if necessary for the construction and installation of the water system improvements within the subdivision. However, nothing in this agreement shall be construed as authorizing Developer to obligate RWSC in any manner related to the installation and construction of any equipment, materials or water system improvements either within or without the subdivision. Developer further hereby releases RWSC and agrees to hold it harmless from any and all claims that Developer has or may have against RWSC for any reason whatever resulting from the agreement to use water obtained from RWSC, and RWSC makes no representation as to the quality of such water, other than it shall be potable.
- 13. No assignment of this agreement in whole or in part for any purpose shall be made or granted by Developer without the prior written consent of RWSC.
- 14. This contract may be changed or modified only with the written consent of Developer and the governing body of RWSC. Such modification may be requested by either party, but shall not in any event be effective until approved by the Board of Directors of RWSC.
- 15. This contract shall be subject to all valid rules, regulations and laws applicable hereto, past, or in the future, promulgated by the United States of America, the State of Texas, and any

other governing body or agency having lawful jurisdiction, or any authorized representative or agency of them.

- 16. If RWSC should be prevented, wholly or in part, from fulfilling its obligation to supply water to the boundary of the subdivision, by reason of any act of God, unavoidable accident, acts of enemy, strikes, fires, floods, conservation of water for those with superior and legal rights to such water, governmental restraint or regulation, or other causes of force majeure, or by reason of circumstances reasonable beyond its control, then the obligation of RWSC to deliver water to Developer's subdivision, as hereinabove provided, shall be temporarily suspended during continuation of such force majeure. No damage shall be recoverable by Developer from RWSC by reason of the temporary suspension of delivery of water due to any of the causes above mentioned. If RWSC's obligations shall be affected by any such causes, RWSC shall promptly notify Developer in writing, giving full particulars of such force majeure as soon as possible after the occurrence of the cause or causes relied upon.
- 17. It is agreed by the parties hereto that this instrument contains in writing all of the agreements between the parties hereto and nothing (except those things required by law) not incorporated herein or by reference shall be binding on the parties. #### Background:

Re:

As the Board is aware, I am retiring and my last day is August 2, 2021. The South Texas Water Authority Board is scheduled to meet on August 3, 2021. STWA Board Officers have been in discussions with Mr. John Marez to hire him as my replacement. Approval of an employment contract is an item on STWA's August 3<sup>rd</sup> agenda.

#### Analysis:

When Mr. Tom Brown, my predecessor, separated from his STWA employment as executive director, the Ricardo Water Supply Corporation named me as general manager. Although Mr. Marez is not officially hired as the new executive director, this item was placed on the agenda for consideration in the event the Board would like to name him as such *effective upon* STWA finalizing his employment — either by contract or reaching a verbal agreement.

#### Staff Recommendation:

I spoke with legal counsel regarding this matter. He recommends limiting the amount of time that the Corporation is without a named general manager. He also recommends wording the motion to name Mr. Marez as general manager <u>effective upon South Texas Water Authority hiring Mr. Marez as Executive Director</u>.

#### **Board Action:**

Determine whether to name Mr. Marez as general manager <u>effective upon South Texas Water Authority hiring Mr. Marez as Executive Director</u>.

#### **Summarization:**

My last day is August 2<sup>nd</sup>. Mr. Marez is expected to be officially hired on August 3<sup>rd</sup>. Taking action contingent on such occurring means the Corporation does not have to meet again and one person is the lead responsible party.
