Information about your Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the RWSC business office at (361) 592-3952.

RWSC is a purchased surface water system. Where do we get our drinking water?

Our drinking water is obtained from surface water sources. In past years, the Corporation has used its own groundwater well. In 2008, that well was taken out of service for mechanical reasons. South Texas Water Authority provides the Corporation with treated water from the City of Corpus Christi whose surface water sources are Lake Corpus Christi, Choke Canyon Reservoir, Lake Texana and Colorado River. In emergency situations, the City of Kingsville's groundwater wells can provide water under a pass through agreement. The City of Corpus Christi's water quality data is also included in this report.

Source Water Assessments

TCEQ completed a Source Water Assessment of your water source and results indicate that some of our sources are susceptible to certain contaminants. The sampling requirements for your water system is based on this susceptibility and previous sample data. Any detection of these contaminants will be found in this Consumer Confidence Report. Water Loss: In the most recent Water Loss Audit submitted to the Texas Water Development Board for the period of January to December 2020, RWSC lost an estimated 15.6 million gallons of water.

Definitions & Abbreviations

Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Action Level Goal (ALG) – The level of a contaminant in drinking water below which there is no known or expected risk to health. ALGs allow for a margin of safety.

Avg – Regulatory compliance with some MCLs are based on running annual average of monthly samples.

Level 1 Assessment – A study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.

Level 2 Assessment – A very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.

MFL – million fibers per liter (a measure of asbestos)

Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) – The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) – The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

mrem – millirems per year (a measure of radiation absorbed by the body)

na – not applicable.

NTU – Nephelometric Turbidity Units (a measure of turbidity)

pCi/L – picocuries per liter (a measure of radioactivity)

ppb – parts per billion, or micrograms per liter ($\mu g/L$) – or one ounce in 7,350,000 gallons of water.

ppm – parts per million, or milligrams per liter (mg/L) – or one ounce in 7,350 gallons of water.

ppq – parts per quadrillion, or picograms per liter (pg/L)

ppt – parts per trillion, or nanograms per liter (ng/L)

Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.

Turbidity has no health effects; however, turbidity can interfere with disinfection and provide a medium for microbial growth. Inadequately treated water may contain disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea and associated headaches.

Cryptosporidium is of great concern in public water systems that treat surface water for drinking water sources. Resistant to disinfectants, Cryptosporidium can cause gastrointestinal illness in individuals who consume contaminated water. The Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR) is required by Congress in order to increase protection from microbial contaminants such as Cryptosporidium. Under this rule, water systems must conduct monthly source water Cryptosporidium sampling over a two-year span. The City of Corpus Christi completed sampling in July 2019.


